Pursuant to your request for extension for the subject claims, I have discussed the matter with Mr. Robert Gardiner, Director of the Bureau of Public Lands, and reviewed in detail the Maine Mining Law for State-owned Lands.

We shall be happy to meet with you or a Superior representative to discuss this matter.





A drill program was completed on the Public Lot in Tl2-R8 between June 14 and June 17, 1982. One hole was drilled for a total of 99 feet.

BX core was recovered using standard BX wireline equipment. County Drilling and Testing was the contractor.

The location of the drill hole is shown on the enclosed sketch. The hole penetrated weakly altered dacite plus andesite or basalt. A drill log is enclosed.
