7	Whereas, The Associated Students of the University of Montana ("ASUM") is bound by its
8	Bylaws;
9	
10	Whereas, ASUM's business is conducted during the academic year;
11	
12	Whereas, There are procedures that are codified in the Bylaws which have the potential of falling
13	outside the academic calendar;
14	
15	Whereas, Article IV, §4(6) of the Bylaws currently reads:
16	
17	If the Board has evidence that a member organization has failed to comply with
18	the stated criteria necessary for ASUM recognition or has failed to meet all the
19	responsibilities stipulated by ASUM, the Board has the option of sending a
20	warning notice to the member organization specifying reasons for the warning
21	and the corrective steps that must be taken within a period of no more than one
22	(1) month. The member organization shall have the opportunity within one $(1)$
23	week to schedule an informal hearing with the Board. If the member organization
24	acts, this hearing must take place within two (2) weeks of the member
25	organization's receipt of the notice. If the member organization fails to act, then
26	they forfeit the right to participate in this procedure.;
27	
28	Therefore, Let It Be Resolved, That Article IV, §4(6) of the Bylaws be amended to read:
29	
30	If the Board has evidence that a member organization has failed to comply with
31	the stated criteria necessary for ASUM recognition or has failed to meet all the
32	responsibilities stipulated by ASUM, the Board has the option of sending a
33	warning notice to the member organization specifying reasons for the warning
34	and the corrective steps that must be taken within a period of no more than <b>four</b>
35	(4) academic weeks one (1) month. The member organization shall have the
36 37	opportunity within one (1) <b>academic</b> week to schedule an informal hearing with the Bound 16 the member organization gets, this hearing must take place within
37	the Board. If the member organization acts, this hearing must take place within two (2) <b>academic</b> weeks of the member organization's receipt of the notice. If the
38 39	member organization fails to act, then they forfeit the right to participate in this

40 41	Fall and Spring semesters.;
