4. Journal ranking and impact

According to the 2018 Journal Citation Reports® (Thomson Reuters), the impact factor of the *EJO* is 1.84. Past figures: 2.03 (2017), 1.62 (2016), 1.44 (2015), 1.48 (2014), 1.39(2013) 1.07 (2012) and 0.89 (2011). In

the category of Dentistry, Oral Surgery & Medicine the EJO has remained in the 2nd quartile of journals and ranks 35th out of 91. The JIF percentile (Journal impact factor percentile) has risen to 60.0%.

5. Most cited article for the 2018 impact factor window

The article by Cecilia Goracci, Lorenzo Franchi, Alessandro Vichi and Marco Ferrari, Accuracy, reliability, and efficiency of intraoral scanners for full-arch impressions: a systematic review of the clinical evidence. Eur J Orthod. 2016 Aug;38(4):422-8, was the most cited article in the 2018 impact factor window. That is to say, the article that contributed most highly to the Journal's current impact factor.

6. Beni Solow Best Article Award published in 2018

The Editorial Board plus the EOS President, Secretary and Treasurer (excluding the Editor and Associate Editors) choose this award through a rigorous 2-stage procedure. The award was won by Niko C Bock, Mitra Saffar, Helge Hudel, Marjut Evälahti, Kaisa Heikinheimo, David P Rice and Sabine Ruf for their article Long-term (≥15 years) post-treatment changes and outcome quality after Class II:1 treatment in comparison to untreated Class I controls. Eur J Orthod. 2018 Apr 6;40(2):206-213. The winners received their award and presented their paper at the EOS annual meeting in Nice.

7. EJO Open Session

The 2019 EOS annual congress in Nice hosted the 8th EJO Open Session. Entitled 'Digital Orthodontics Friend or Foe?', the session gave a stimulating perspective on this topical field. The speakers, Björn Ludwig, University of Homburg/Saar, and Dirk Wiechmann, Hannover Medical School, delivered high calibre presentations focusing on the integration of digital orthodontics in daily clinical practice and on current technical developments. Dirk Bister, University of London and EJO Associate Editor, was an excellent organiser and moderator. This provocative event was open to all EOS congress delegates and attracted several hundred attendees that were involved in a lively discussion in the auditorium.

8. The Associate Editors, the Editorial Board and Officers of the EOS

Yijin Ren, University of Groningen, has been appointed associate editor. The associate editors, the editorial board and officers of the EOS have been very effective in: editing and reviewing manuscripts; advising on ethical, scientific and logistical matters; selecting the Beni Solow award winner, organising the EJO Open session and helping to shape the future direction of the Journal. I wish to thank them all for their excellent work and erudite support they give the journal.
