

HONORABLE RAFAEL ANGEL CALDERON FOURNIER

Honorary Doctor of Public Administration

Former Costa Rican President Rafael Angel Calderon Fournier is an attorney and a professor of international politics at Costa Rica National University. During his presidency, Costa Rica made tremendous advancements on both the social and economic fronts, as the Calderon administration implemented economic reforms and invested in health care, education and housing. These efforts resulted in Costa Rica's being classified by the United Nations Development Program as a country with a high index of human development.



President Calderon has had a lifelong interest in public service. He is the son of former Costa Rican President Rafael Angel Calderon Guardia and at the age of 16 attained his first office, secretary of high school affairs of the Calderonista Youth. He led the opposition in Costa Rica for many years. President Calderon has served in the Costa Rican Congress and as secretary of foreign affairs. In 1990, he was elected president.

President Calderon is a graduate of the University of Costa Rica School of Law. He is a member of the Costa Rican Bar Association and a senior partner in Calderon & Associates.

HONORABLE HARRIET L. ELAM-THOMAS

Honorary Doctor of Public Administration

US Ambassador to Senegal Harriet L. Elam-Thomas, a Boston native, is a senior foreign service officer with the rank of career minister. She has been ambassador to Senegal since 1999 and has worked closely with Suffolk University as it developed a campus in Dakar, Senegal, for West African students and for American students participating in summer studies in Senegal.



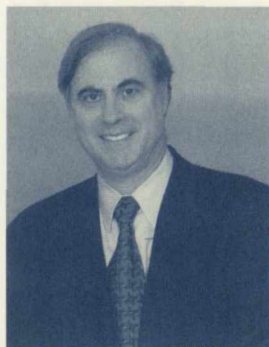
Ambassador Elam-Thomas was counselor and acting deputy director of the US Information Agency before it became part of the State Department in 1999. She has served at the United Nations and in Greece, France, Belgium, Turkey, Mali and the Ivory Coast. At the end of her Athens tour, she received the US government's Superior Honor Award for improving US-Greek cultural relations and a similar award from the Piraeus Cultural Association in Greece. She received USIA's Lois Roth Award for Excellence in Information and Cultural Diplomacy and a Turkish Educational and Cultural Foundation award for improving US-Turkish cultural relations.

Ambassador Elam-Thomas holds a bachelor's degree in international business from Simmons College and a master's degree in public diplomacy from Tufts University's Fletcher School of Law and Diplomacy.

ROBERT E. HIRSHON

Honorary Doctor of Laws

As president of the American Bar Association, Robert E. Hirshon is focused on increasing access to the justice system. He practices law with the firm Drummond, Woodsum & MacMahon in Portland, Maine, where he concentrates on commercial litigation and legislative and regulatory advocacy.



Mr. Hirshon served as president of the Maine State Bar Association in 1986 and was chair of the association's Continuing Education Committee. He is a past president of the Maine Bar Foundation and has served as its director and chair of its Bankers' Advisory Committee. He was chair of the American Bar Association's Tort and Insurance Practice Section and was a founding member and first chair of the ABA's Steering Committee for the Center for Pro Bono. Mr. Hirshon was recognized by the Maine Legislature for his community service and has received awards for his pro bono leadership. He has published numerous articles on insurance regulation in trade and business publications.

Mr. Hirshon is a graduate of the University of Michigan, where he received a bachelor's degree with distinction and a juris doctor.

RICHARD M. LINNEHAN, DVM

Honorary Doctor of Science

Dr. Richard M. Linnehan, a native of Lowell, Massachusetts, is a NASA astronaut and veterinarian who has flown three space shuttle missions.

Dr. Linnehan has been in private veterinary practice and worked in zoo animal medicine and comparative pathology before he was commissioned as a captain in the US Army Veterinary Corps. At NASA, he first flew as a mission specialist on the Life Sciences and Microgravity Spacelab mission, then served as the payload commander on the Neurolab mission. In his third flight, he performed three space walks as he helped service the Hubble Space Telescope.

Dr. Linnehan is a faculty member of North Carolina State University College of Veterinary Medicine in Raleigh-Durham. Among the honors he has received are the Navy Commendation Medal, two NASA Space Flight Medals and the NASA Outstanding Leadership Medal.

He received a bachelor's degree in animal sciences with a minor in microbiology from the University of New Hampshire, and a Doctor of Veterinary Medicine from the Ohio State University College of Veterinary Medicine.



US REPRESENTATIVE EDWARD J. MARKEY

Honorary Doctor of Laws

US Representative Edward J. Markey, dean of the Massachusetts Congressional Delegation, has made telecommunications policy his bailiwick and has fought for consumer rights, health reform, environmental conservation and elimination of large monopolies since he was first elected to Congress in 1976. He has been rated a “legislative hero” by the Conservation Law Foundation, the Consumer Federation of America, the Children’s Defense Fund, the National Education Association and Taxpayers for Common Sense.



Congressman Markey led the charge to mandate a minimal amount of educational television programming for children through the Children’s Television Act of 1990. He authored the 1996 V-chip law that led to a TV ratings system. The congressman is leading the House effort to protect the Arctic National Wildlife Refuge, while working to increase automobile fuel efficiency and thus reduce dependence on foreign oil. He also is working to improve defenses against terrorism at nuclear power plants and liquefied natural gas facilities.

The Congressman has a bachelor’s degree from Boston College and a juris doctor from Boston University Law School. He served in the US Army Reserves and served two terms in the Massachusetts Legislature.

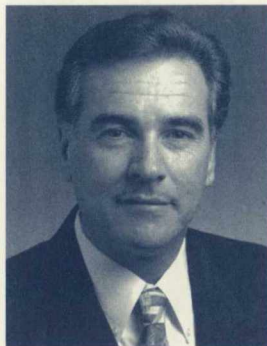
JOHN J. "JACK" NUGENT

Honorary Doctor of Commercial Science

John J. "Jack" Nugent is president and CEO of BJ's Wholesale Club, one of the fastest growing companies in the wholesale club retail industry.

Mr. Nugent joined the Natick-based company in 1989 as senior vice president of sales operations. He was named president in 1993 and elected chief executive officer in 1997. Before joining BJ's, Nugent was with the Child World toy retail chain for 26 years. He initially loaded trucks for the firm and rose to the position of vice president of operations with responsibility for all 175 stores in the chain.

BJ's Wholesale Club has an enthusiastic company culture, which was demonstrated when employees seeking a way to help the victims of September 11 came up with the idea of selling American flag pins and donating the proceeds of the sales. BJ's raised \$400,000 for the Red Cross. A strong commitment to charity has been evident throughout Mr. Nugent's career. He has been particularly active as a fund-raiser for the Cardinal Cushing Centers, and was cited as "Humanitarian of the Year" in 1994 for his efforts on behalf of the school.



US REPRESENTATIVE CHARLES B. RANGEL

Honorary Doctor of Laws

US Representative Charles B. Rangel, dean of the New York State Congressional Delegation, is a founding member and former chairman of the Congressional Black Caucus. He is the principal author of the \$5 billion Federal Empowerment Zone, aimed at revitalizing urban neighborhoods, and he authored the Low Income Housing Tax Credit, which has been critical in financing affordable housing nationwide.



Congressman Rangel is the ranking member of the Committee on Ways and Means and serves on its Trade Subcommittee. He is a member of the Joint Committee on Taxation, Deputy Democratic Whip of the House of Representatives and a co-chair of the Democratic Congressional Campaign Committee. The congressman is attentive to trade with the Caribbean and Africa. As a congressional adviser to the US trade representative, he is involved in international conferences and negotiating sessions on trade issues.

Rangel served in the US Army in Korea and was awarded the Purple Heart and Bronze Star. He is a graduate of New York University and St. John's University School of Law.

THE HONORABLE MARTHA B. SOSMAN

Honorary Doctor of Laws

The Honorable Martha B. Sosman is an associate justice of the Supreme Judicial Court of Massachusetts, appointed by Gov. A. Paul Cellucci in 2000. She also served as an associate justice of the Massachusetts Superior Court from 1993 to 2000, where she was specially assigned to handle the lawsuit brought against the tobacco companies by the Attorney General's Office. During the 1980s, Justice Sosman was an assistant US attorney and chief of the Civil Division of the US attorney's office in Boston.



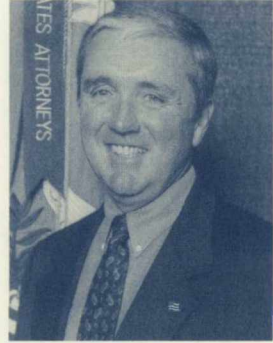
She was a founding partner of Kern, Sosman, Hagerty, Roach & Carpenter, PC, which at the time of its founding was the largest all-woman law firm in Massachusetts. She began her legal career as an associate at Foley, Hoag & Eliot, Boston.

Justice Sosman received her bachelor's degree, cum laude, from Middlebury College, where she was a member of Phi Beta Kappa. She received her juris doctor, magna cum laude, from the University of Michigan Law School, where she was awarded the Henry M. Campbell Memorial Prize.

MICHAEL J. SULLIVAN

Honorary Doctor of Laws

Michael J. Sullivan is the US attorney for Massachusetts and since his appointment in September 2001 has coordinated the Commonwealth's Anti-Terrorism Task Force in addition to his traditional duties as the state's chief law enforcement officer.



His career in government began in 1991 when he became a Massachusetts state representative. He was appointed district attorney of Plymouth County in 1995, followed by two more elections to that office. As district attorney, he targeted child abuse, domestic violence and elder abuse and reduced the district court backlog by about 95 percent. In private practice, he was a partner with McGovern & Sullivan, PC, and an associate counsel with Bolles & Pritchard, both in Holbrook.

US Attorney Sullivan has served on the Governor's Commission on School Safety and the Governor's Commission on Father Absence and Family Support. He is past president of the Massachusetts District Attorney's Association and served as a member of the Attorney General's Urban Alliance.

He received his bachelor's degree, cum laude, from Boston College. He earned a juris doctor, cum laude, from Suffolk University Law School.

THE HISTORY OF SUMMA

In the tenth century, companies of scholars began to live and work together in guilds, following the custom of craftsmen and merchants. Every guild was then known as a *universitas*. As the reputation of the first scholarly guilds began to spread, the word *universitas* became the exclusive property of the academicians. Before the settlers of Boston arrived from the Old World in the seventeenth century, it had long been the habit and privilege of princes and prelates to found, build, and endow colleges and universities. What had been the privilege of a few in Europe became the personal responsibility of many in New England.

Suffolk University, founded in 1906, is clearly a link in the chain that stretches back over ten centuries. Suffolk further resembles the earliest European universities in that its graduate faculty preceded its undergraduate.

Another ancient tradition associated with higher education is the granting of honors at various levels to students upon graduation, the highest honor being *summa cum laude*. As the word *summa* denotes academic achievement of the highest distinction, by extension *summa* can also mean leadership and outstanding example. Suffolk University chooses to recognize as members of *Summa* those alumni and friends who, by their generosity, deserve this distinction.

MEMBERSHIP

Alumni and friends who become members of Summa demonstrate exceptional pride and confidence in Suffolk University, both to the “inner family” and to the outside community. The University’s stature is thus greatly enhanced by their support.

The funds made available by Summa members are invaluable to the University and provide support to programs that will advance the institution’s mission. Summa contributors make a difference by providing resources for scholarships, financial aid, faculty research and writing; by sustaining and upgrading library resources; by maintaining and enhancing the physical plant; and by offering extracurricular programs, all of which provide a well-rounded educational experience for students at Suffolk University.

Donors who contribute \$1,000 or more to any fund (capital campaign, annual operating, and restricted or endowments) in a given fiscal year (July 1-June 30) to Suffolk University are designated members of Summa. Within Summa, the following clubs are acknowledged:
