Dear Mr. Sutherland,

I have ~~not~~ ~~not~~ ~~an~~ never received  
my pay check covering period from  
7/19/42 to 8/11/42.

The time period for the above  
mentioned period has not been  
questioned, but I was advised  
some two or three weeks ago  
that checks for this period  
had been missed.

I have written and asked  
where check was sent and who  
sent it - but no reply -

I have mailed twice sheet for period. 8/2/42 to 8/15/42

I have been notified this sheet was incorrect and two different sheets sent me mailed me for signature covering this period. I have declined to sign either of them for the reason that both were incorrect.

I mailed you the last one sent me. When I was docked on Aug. 8th to 4 hrs. when in truth and fact as shown by the records I worked all that day. (Aug 8-42) and traveled 101. mls. I wrote you my reasons for declining to sign this sheet and have heard nothing in reply.
