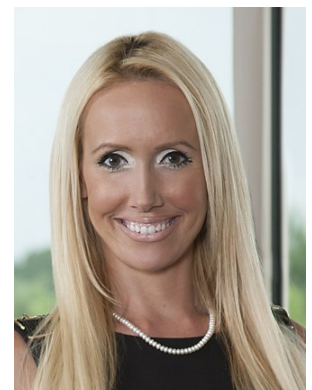

Florida Statutes Sec. 90.704 “Basis of Opinion Testimony by Experts” (2015)

This section was amended effective July 2, 2013 to prohibit the disclosure of inadmissible facts or data to a jury by the proponent of an expert opinion or by inference unless the court determines that their probative value in assisting the jury's evaluation of the expert's opinion substantially outweighs their prejudicial effect. As a result of the amendments, the effect of s. 90.704, F.S., is conformed to the effect of Federal Rule of Evidence 703. (Adopting the Daubert for admitting expert witness testimony)
