## Counseling, Mediation, & Complaint Program

Discrimination in employment within USDA based on a person's race, color, religion, sex, national origin, age (if over 40), physical or mental handicap, sexual harassment, marital status or reprisal for equal employment activity is prohibited by Federal law and Department Regulations. Call 8 or (202) 447-7179 24 hrs. for information on the EEO Counseling, Mediation, & Complaint Program.

USDA employees or applicants for employment who believe they have been discriminated against in an employment decision for any of the bases listed above may file an EEO complaint. To file a formal complaint of discrimination the individual must first contact an EEO Counselor/Mediator within 30 days of the alleged discriminatory incident, or of reasonably learning of the possible discriminatory nature of the incident. The EEO Counselor/Mediator will attempt to mediate/resolve the issue.
