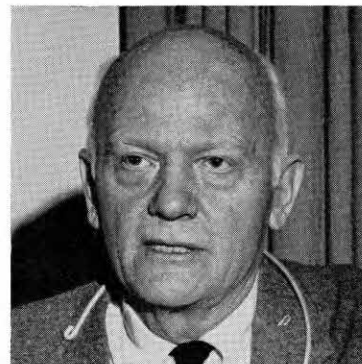


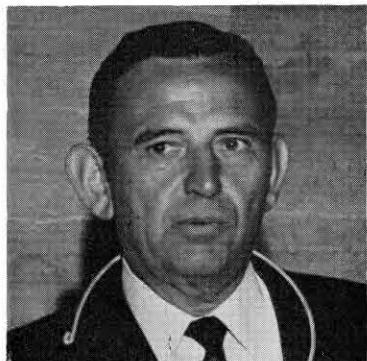

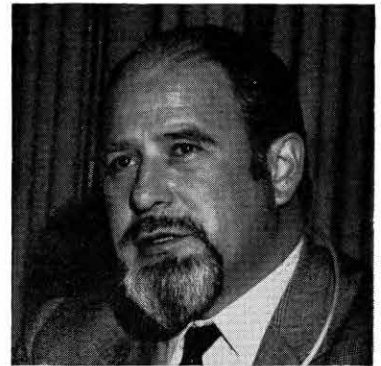
Stanley L. Block (*Anxiety, Defense and Cognition: A Theoretical Basis for Practical Handling of the Surgical Patient*) is director of the department of psychiatry at Jewish Hospital in Cincinnati and associate clinical professor of psychiatry at the University of Cincinnati. A graduate of the University of Cincinnati College of Medicine, he interned at Jewish Hospital, Brooklyn, N. Y. Following his residency at Cincinnati General Hospital, he took further postgraduate training at the Chicago Institute for Psychoanalysis. Dr. Block is also visiting associate professor of psychiatry at the University of Kentucky.

Douglas D. Bond (*Changing Concepts of Deviance and Perspectives in the Behavioral Sciences*) is professor and chairman of the department of psychiatry at Case Western Reserve University School of Medicine and director of psychiatric services for the University Hospitals of Cleveland, Ohio. 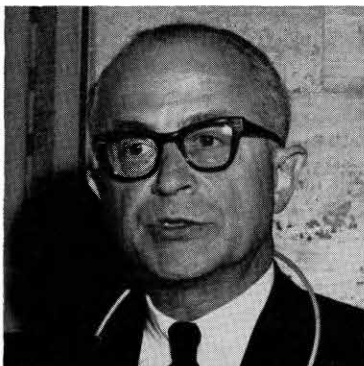
Ewald W. Busse (*The Older Population and the Aged Patient*) is J. P. Gibbons Professor and chairman of the department of psychiatry at Duke University. A graduate of the Washington University School of Medicine, he interned at St. Louis City Hospital. Following his residency at Colorado Psychopathic Hospital, he taught at the University of Colorado as head of psychosomatic medicine. He is past chairman of the Training Commission of the Advisory Council of the National Institute of Child Health and Human Development. He is also director of the Duke University Center for the Study of Aging and Human Development.

Luther Christman (*Community Resources—The Role of Other Professionals*) is professor and dean of the Vanderbilt University School of Nursing and director of nursing for the Vanderbilt University Hospital. A bachelor-degree graduate of Temple University School of Nursing, he took postgraduate training in clinical psychology at Temple and received his Ph.D. in sociology and anthropology from Michigan State University. 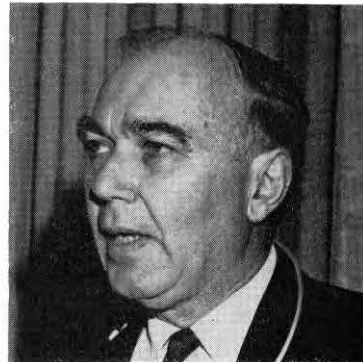

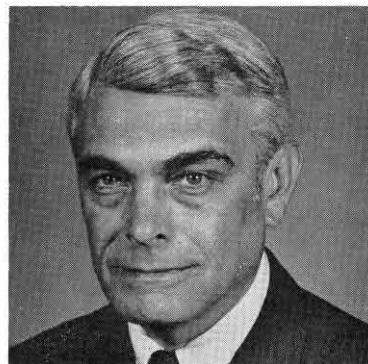

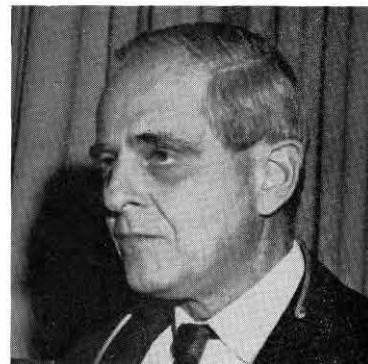
