MOORE NAMED DEAN

David G. Moore was appointed IIR's fourth Dean effective September 1. He comes to Cornell from Michigan State University where he was professor of management and sociology and head of the Department of Management in the College of Business.

He is a graduate of the University of Illinois where he received his M.A. in sociology, and of the University of Chicago where he received his Ph.D. in sociology. Prior to his academic career, he worked in personnel staff and administrative activities for Western Electric and Sears Roebuck and Company. For Sears, he served as personnel director of the David Bradley Company.

After ten years of business experience, he joined the faculty of the University of Chicago in sociology and industrial relations. There he initiated an extensive employee attitude survey program and was also coauthor of the SRA Employee Inventory. Later at the University of Chicago he became associate professor of business administration and director of the well-known executive program there.

Dean Moore has contributed chapters to several books in the field of management and is co-author with Burleigh B. Gardner of Human Relations in Industry, now going into its fourth edition. He has recently co-authored a book, The Enterprising Man, about men who start businesses.

The Moores, who have purchased a home at 220 Berkshire Road, have two children, David, age 10, and Kathryn, age 9. And last but not least is the family Bassett hound named Huckleberry.

OTHER APPOINTMENTS

Dean Moore has announced the appointment of Robert F. Risley as assistant deen and director of extension. Risley has been serving as acting deen since the resignation of former Dean John McConnell last January.

Other administrative personnel are Miss Doris Stevenson, acting administrative assistant and Mrs. Virginia Tull, administrative aide.

SCHOOL CONVOCATION HELD

Faculty, staff, and students gathered for their annual convocation in Ives Auditorium on Wednesday, September 25. The program consisted of the presentation of awards and scholarships to outstanding students and short speeches by faculty and visitors.

Mrs. Irving M. Ives, wife of the late Senator Ives, the School's first dean, presented three cash awards to Robert C. Schubert '66, Andrew Abraham 65, and Deborah Schuster '64. Peter Bundarin '63 received his award last June. The prizes were presented in memory of Ives, to students demonstrating good faith, integrity, responsibility, cooperativeness, and good will. Mrs. Ives then quoted the declaration contained in the 1940 Report of the Joint Legislative Committee on Industrial and Labor Conditions, which says in part:

Though we may legislate to the end of time, there will never be industrial peace and harmony without good faith, integrity, a high degree of responsibility, and a real desire to cooperate on the part of all parties concerned. Without this spirit of good will, all of the social, economic and labor laws of man will prove even-

tually to be in vain.

She said that good faith cannot be ground out in legislative halls, that integrity and responsibility go hand in hand, that cooperativeness can be challenging but cannot be legislated, and that if you don't have good will, you cannot mediate or cooperate to the fullest extent. It cannot be forced; it can be generated by diplomacy and tactfulness.

Dean David Moore was them introduced by Assistant Dean Robert F. Risley. He said that as a newcomer to the School he can view it in a somewhat detached manner.

"...The history of the School up to this point has been written entirely by others. Some sense of the great contribution of Senator Ives has been given by Mrs. Ives. His wisdom, foresight, and sense of justice are important parts of the spirit of the School. I am referring in the first instance to those men and women who have been here since the School's beginning, like Professors Emerson, Jensen, Konvitz, McKelvey, Neufeld, and Smith. These and all the others who have followed have contributed something of themselves in raising the stature of education and research in the industrial and labor relations field.

"Yet something has happened here which has resulted in a dedication that is more than a routine commitment to a mundame subject matter. I suspect that what has happened here can be attributed to the sense of mission which has characterized the School from its beginning and to the quality of the faculty initially and subsequently attracted to the School as a consequence of this sense of mission. We catch a feeling of the School's humanistic mission when we read Professor Konvitz's eulogy of Senator Ives and President Day on the occasion of the move into Ives last October.

"We discover still another aspect of the sense of mission characterizing the faculty of the School when we read the note of appreciation to Professor William F. Whyte which appears at the beginning of the book, Money and Motivation, and which was written by other contributors to that volume. Here we find another aspect of faculty dedication which has raised and enhanced the stature of this School. Professor Whyte illustrates the faculty's dedication to science and the search for concrete knowledge.

"Yet another current that has characterized the School has been the concern with teaching at all levels. Somehow we have been able to maintain our academic integrity and yet serve the people of the state in all walks of life."

RETURNEES FROM ABROAD

Not in recent years has the School had such a rash of returning travelers, both long-term and short-term. Six have returned from prolonged absences.

Leonard P. Adams has been in India for the past year under a Ford Foundation-sponsored labor relations research project. He has returned to his former position as Director of Research and Publications.

Isedore Blumen, under a Fulbright grant, has been teaching for the past year at the University of Groningen, The Netherlands.

Dr. Temple Burling has been teaching at the University of Ankara, Turkey for the past year under the Cornell-BPA School program. He also studied the meaning and philosophy of work in a Moslem society in transition from a peasant to an industrial economy.

Gardner Clark spent the Spring semester and past summer in Europe studying the extent to which the Soviet foreign trade and aid policies are economically motivated. He spent the last month in Russia.

Alice Cook has been teaching at Keio University in Japan for the past year, plus extensive traveling in the Philippines, Indonesia, Korea, Saigon, Hongkong, and Singapore.

Emil Mesics spent the Spring term conducting one-week seminars for management, union, and university groups in five major industrial cities of Colombia.

OTHER FACULTY RETURN

F. F. Foltman spent his sabbatic year as consultant to the Bureau of Employment Security, Washington, D.C. He worked primarily with the U. S. Employment Service, helping to plan and conduct research on youth problems and employment of persons in professional occupations.

George Hildebrand, under a Ford research professorship, spent the past academic year completing a study on the postwar economy of Italy.

IRVIN LEAVES IIR

Floyd Trvin, counselor in the School's Office of Resident Instruction, has accepted a position as assistant professor in Purdue University's Department of Psychology. He also will be counseling psychologist at the University's Counseling Center. Irvin received his Ph.D. at Cornell in 1961.

TWO ON SABBATIC

Robert Aronson is spending his sabbatical year as visiting professor and research associate at the University of California (Berkeley). He is teaching at the School of Business Administration and conducting research at the Institute of Industrial Relations.

James Morris is on sabbatic leave during the Fall semester. He is completing a manuscript on the origins and development of the Chilean labor relations system.

VISITORS AT IIR

Professor Ricardo Hornet Caceres has been named visiting fellow at the School for the coming year. He is professor of Sociology at the University of Arequipa, Peru. He will be under Professor Whyte's aegis.

Professor Toshiya Kohdo of Kansai University will be at IIR during October and November. He is assistant professor of industrial and labor relations in the Faculty of Commerce at Kansai. He will occupy Room 168 during his stay.

FALL CONFERENCES SLATED

Five on-campus conferences are slated during the next month. First was a week-long (September 30-October) Training Conference for 11 staff of District 4, United Steelworkers of America. Ronald Donovan was conference chairman. IIR faculty participating were Dean David Moore, N. Arnold Tolles, M. Gordner Clark, George H. Hildebrand, and Jean T. McKelvey.

The sixth annual Joint Labor-Management Conference for the New York State Building Construction Industry was held October 6-8 under the chairmanship of Harlan B. Perrins. The conference agenda included problem areas where cooperative action by labor and management will benefit industry, the public, and the parties concerned.

The fifth Wilhelm Weinberg Lebor-Management Seminar, with about 30 attending, will be held October 13-18. The theme will be "The Public Interest in Our Changing Society: New Roles for Lebor and Management." Co-chairmen are Leonard P. Aries of the National Conference of Christians and Jews and Wayne L. Hodges of IIR.

Included in the program will be Victor Reuther, Vice President, UAW, Hobart Taylor, Jr., Executive Chairman, President's Committee on Equal Employment Opportunity, John Snyder, President, U. S. Industries, Herry Van Arsdale, President, New York City Central Labor Council, Theodore W. Kheel, labor arbitrator. IIR faculty on the program include Dean Moore, N. Arnold Tolles, F. F. Foltman, and Lawrence K. Williams.

Meeting for two days, October 22-23, will be the Industrial Training Council of New York State, with the theme "Economic and Social Dimensions for Manpower and Development." Twenty-five members will hear discussions on the impact of technology in those areas of concern to training. Dean Moore will discuss "Social Research and Executive Development" at the opening dinner. Other IIRers taking part will be Lawrence K. Williams, Fmil Mesics, Ned Rosen, and George H. Hildebrand.

Robert F. Risley is president-elect of ITC for the coming year.

A three-day Water Utility Management School for the New York Section, American Water Works Association will be held October 30-November 1, with Harlan Perrins as conference chairmen. Speakers will include Professor Robert G. Smith of Colgate, Armand Adams, Counsel to the Joint Legislative Committee on Revision of Conservation Law, and Professors Alpheus W. Smith and Harlan Perrins of IIR.

LETTER FROM LIBERIA

John Paterson, administrative assistant-on-leave, writes from Monrovia, Liberia, where he is helping to develop administrative services for the University of Liberia. His wife and two children are with him:

"Going over, the plane was full of all decriptions of foreign people. Our first stop was at Dakar and then on to Monrovia. Carlton Wright, project director, was there to meet us. We cleared customs with our nine suitcases and after one hour's ride, arrived at our home near the Police Academy which is 10 miles from the city and University.

"We have a large house, new, completely furnished with three bedrooms, three baths, large living room, dining room, kitchen, screened porch and carport. A breezeway connects the house with the house-boy's cuarters, storage and laundry room. This is in a new housing area with 14 new pre-fab houses with aluminum siding and metal roofs - all made in the US and shipped over here. Each bedroom is air conditioned and there is a large fan in living room.

"After visiting AID headquarters, embassy, etc. on Wednesday a.m., I reported for work. After two-and-a-half days of work I can well see the tremendous job ahead of me but I think I can be of some help. Office hours are from 7 to 4.

"All the femily are well. Were very tired on arrival but are o.k. now.

Later: I had my first staff meeting - - the Business Officer and all his staff (15). A lot of problems, a lot of work, but the type I enjoy."
