## Problem Identification

- There is a considerable lack of understanding about service animals in the following ways
  - Utility and services they provide
  - Law and regulations regarding access and accommodations
  - Differentiation between various types of support animals

#### Public Health Cost and Unique Cost Considerations

- There is very little data available regarding service animal use and healthcare costs
- Service and support animals can be tremendous tools to help not only patients but health systems in general
  - Patients with PTSD reported improvements in mood, loneliness, and safety [Stern]



## Community Perspective and Support

Back of house staff (nurses, LNA's, physicians)

- "I'm not sure when I [a PCP] should intervene and suggest a service animal" – MD #1, Milton Family Practice
- "I don't know the difference between service dogs or emotional support or therapy dogs" – MD #2, Milton Family Practice
- Front of house staff (receptionists, schedulers)
  - "I don't feel comfortable asking someone about this"

# Intervention and Methodology

- Created short informational flyers for around the office setting for the following information
  - Types of assistance animals and their legal protections
  - Standardized questions to ask those who present with a service animal
- Created housing request template/ dot-phrase for Epic

## Result/Response



- Receptionists and schedulers
  - Implemented flyer with various types of support animals and roles/limitations/legal protections allowed by each role category
  - Included standardized questionnaire to ask patients with service animals
- Physicians, nurses, and support staff
  - Elucidated various types of assistance animals
  - Created standardized letters of support for housing letter requests

## Evaluation of Effectiveness

Receptionists and schedulers

- Front desk staff stated that this was helpful and that they would likely use these documents in the future
- Physicians, nurses, and support staff
  - All physicians interviewed/consulted for this project stated that this was "helpful" and said that they would utilize these postures and housing form

#### Recommendations for Future Proects/ Interventions

- Further rules and guidelines to be implemented on a hospital or state and national level
- Research on states of health and healthcare utilization before and after addition of an assistance animal to the treatment team
- Research into efficacy of service animal intervention at monitoring disease and improving outcomes and quality of life
