STATE OF NEW HAMPSHIRE.

To the Inhabitants of the Town of Woodstock in the County of Grafton in said State, qualified to vote in town affairs.

You are hereby notified to meet at the Town House in said Woodstock on Tuesday, the thirteenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary town officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same.
3. To see if the town will authorize the selectmen to hire such sums of money as may be necessary to pay town debts.
4. To see what sum of money the town will raise for support of highways.
5. To see what sum of money the town will raise for Memorial day.
6. To see what sum of money the town will raise for support of schools.
7. To see if the town will vote to erect a building to be used as a library.
8. To see what sum of money the town will vote to raise toward paying town debt.

9. To see if the town will authorize the selectmen to place a fountain on parcel of land recently deeded to the town by Mrs. C. L. Parker and to lay out five dollars as requested by deed of same.

10. To see if the town will vote to buy a stone crusher.

11. To see if the town will authorize the selectmen to erect a building at the reservoir to store tools in.

12. To see what action the town will take in regard to straightening and widening School street.

13. To see if the town will authorize the selectmen to sell the electric light charter to private individuals.
