## CURRICULUM VITAE

Daniel Pato Kaboré was born on January 1st, 1956 in Tanghin, Bingo in the province of Boulkiemdé, Burkina Faso. He attended the University of Ouagadougou and obtained his *Maitrise* in Economics. In 1982, he joined the International Crop Research in the Semi-Arid Tropics as a junior researcher. In 1984 he registered at the CIRES (*Centre Ivoirien de Recherches Economiques et Sociales*), Abidjan, University of Côte d'Ivoire for his *doctorat de 3e Cycle* in agricultural economics. After graduation in 1988, he was hired by INERA (*Institut d'Etudes et de Recherches Agricoles*) as an agricultural economist within a research team in a development project financed by the European Development Fund and implemented in the North-west region of Burkina Faso. Two years later, he moved to Ouagadougou as a research team leader for the Central part of Burkina Faso. Simultaneously, he served as an assistant professor at the Faculty of Economics, University of Ouagadougou. A scholarship from the Sustainable Agricultural and Natural Resource Management (SANREM) project gave him the opportunity to register at the Virginia Polytechnic and State University, Blacksburg., USA. He received a Master of Science in Agricultural and Applied Economics there in 2000. The field work he conducted in 1999 in Mali where the SANREM was implemented, served not only for his masters degree but also and later for this thesis. In 2003 he received a scholarship from the University of Groningen, The Netherlands to complete his Ph.D following the so-called 'sandwich system'. Since April 2007, he joined the *Centre d'Analyse des Politiques et Sociales* (CAPES) as a development economist.
