What follows is a personal sampling of the vast literature on the history of sexuality. The subject is of course endless and we have therefore concentrated, although not exclusively, on those areas in which the most innovative modern studies have appeared: England, France, Holland, and the United States. Popular accounts or 'coffee-table' histories of sexuality have been omitted, even though these publications are often valuable for their rich illustrations.

The first part of the bibliography (A) contains the general studies of heterosexuality and homosexuality; studies of the family which are relevant to the subject have also been included. The second part (B) lists studies of individual aspects of sexuality.
