Summary	The collection includes materials on investigations into NCAA violations in the football and basketball programs that resulted in Marshall University being placed on probation for one year, beginning on October 22, 1969, for violations relating to financial aid, ethical conduct, and recruiting. The university was suspended from the Mid-American Conference (MAC) on July 23, 1969, for an indefinite period. Other parts of the collection relate to the firing of football coaches, the head basketball coach, and the athletic director in the aftermath of the violations. Folders on the athletic department contain documentation on these and other matters just prior to the 1970 plane crash and one folder on its activities in the aftermath of the tragedy. The president's files from the early to mid-1970s include information on the work of various committees at Marshall. Correspondents include university presidents Roland Nelson, Donald Dedmon, John Barker, Sam Clagg, and Robert Hayes; football coaches Perry Moss, Pete Kondos, Jim Moss, and Red Dawson; basketball coaches Ellis Johnson and Stewart Way; athletic directors Edgar Barrett, Charles Kautz, Ed Starling, and Joe McMullen. Later materials document the firing of athletic director Joe McMullen and include the papers of his successor, Dr. Lynn Snyder.
