BOERGER, WILLIAM A.

William A. Boerger came to Stearns County in June, 1898. He was married November 5, 1895 to Wilhelmine Schmitt. At the time of his marriage there were two other couples married at the same time, they were George Schmidt and Emma Schaeffer, and Joseph Karst and Elizabeth Edrich. The priest that performed the ceremony was Rev. Father Lamesch of Ipswich, South Dakota.

When he came to Stearns County he lived in Jacobs Prairie, near Cold Spring where he taught school for two years. He then came to St. Cloud and taught in the St. Mary's School. He was organist there for seven years. He also held several political offices.

William then took a position with Henry Lemprich in the court house as a clerk, and in 1910 he was made city editor at the Times Publishing Company. He kept this job for two years when he was made Superintendent of schools in the Fall of 1910. He held this position until June 7, 1935.

William and Wilhelmine (Schmitt) Boerger have seven children they are: Albert A., Bernard, Herbert, Lawrence, Marcellus, Erma, and Julietta.
