It has been found to be quite accurate even with a drop in high school population. This is due to an increase in adult learners and certification requirements.

C. INSTITUTIONAL SUPPORT FOR ROTC

The President of Fort Hays State University, the Vice President for Academic Affairs, the Special Assistant to the President, the Dean of Instruction, and even the Executive Director of the Hays Chamber of Commerce have all stated that they are highly in favor of ROTC at FHSU. It is their consensus that such a program would not only be beneficial to the students and the University but to the defense of the nation.

A recent survey of the entire faculty indicated that 67.9% are in favor of an ROTC Program at this University. The Faculty Senate does not convene again until December of 1979, so we can't speak to Senate Faculty support.

Fort Hays State University is willing to provide budgetary, clerical, facilities (office and classrooms, drill areas, indoor and outdoor firing range, storage facilities,) and administrative support to a military science department.

D. STUDENT SUPPORT

A random survey of 100 students was conducted in November 1979. When asked the question:

Do you favor the establishment of an ROTC program at FHSU

64% responded yes

34% responded no

6. These costs are an increase over 1978/79 costs. With the rapid increase in inflation it is expected that ROTC would have a decided appeal to male and female students.

H. TIME AND DISTANCE FACTORS

- It is 189 miles from Wichita State University to Fort Hays State University. Travel time is estimated at approximately 4 hours at 55 miles per hour. Travel is on Interstate 35 and Interstate 70, both excellent 4 lane highways.
- 2. Terrain Hays, Kansas is located in the Great Plains with an elevation of approximately 2000 feet above sea level. It has slightly rolling hills.

- 3. Weather The average annual temperature is 53.9°F with January averaging 28.4°F and July 79.°F. Cold air from the north moves easily across the flat plains in winter, and hot winds sweep up from the south in summer. Short periods of severe cold and light snowfall occur throughout the winter months. Annual average precipitation is 22.77 inches and the annual average snowfall is 19.5 inches. There are about 11 months open weather.
