NOTICE OF PUBLIC HEARING

Under authority granted by Congress in the Flood Control Act approved 24 July 1946, a comprehensive Master Plan of Reservoir Development and Management is being prepared which will consider recreational developments in connection with the Garrison Reservoir Project on the Missouri River in North Dakota.

General features of a proposed plan for a recreational program, as well as other land and water use management activities, are being developed for this project in cooperation with interested Federal and State agencies.

In order that interested parties may be informed concerning the proposed plan and may have an opportunity to express their views frankly, fully and publicly, a PUBLIC HEARING will be held by the District Engineer, Corps of Engineers, Garrison District, on 26 May 1953 in the City Auditorium, Garrison, North Dakota, beginning at 2:00 p.m.

Additional hearings are also scheduled to be held on 2 and 16 June 1953 at New Town and Baulah, North Dakota, respectively. The public will be advised further regarding these meetings.

All interested parties are invited to be present or represented at the hearings. Information is particularly desired as to the extent to which State and local governmental agencies, and local organizations might be able and willing to participate in the development and financing of public park and recreational facilities and in the maintenance, management and operation of these facilities. Information is also desired as to the extent to which highway interests might develop, improve and maintain adequate access roads to recreational areas proposed for development on Government-owned lands.

Oral statements will be heard, but for accuracy of record, all important facts and arguments should be submitted in writing. Written statements may be handed to the District Engineer at the hearing, or mailed to him.
