**Combating Human Trafficking Through the Global Financial Sector**

Cardozo Professor Barry Koch, a global leader in anti-trafficking efforts, will talk about his work as a Commissioner of the Financial Sector Commission to Combat Modern Slavery and Human Trafficking. The Commission, convened by the governments of Australia, The Netherlands and Liechtenstein, and Nobel laureate Muhammad Yunus, published its Blueprint for Mobilizing Finance Against Slavery and Trafficking at the United Nations General Assembly in 2019.

Professor Koch will discuss several of the Blueprint's goals, including how compliance professionals in the financial sector can "follow the money" to disrupt and dismantle the business of trafficking in persons. He will describe how he and his former compliance colleagues developed and implemented the first automated model in the banking industry to identify customer and transactional characteristics indicative of labor and sex trafficking.
