Your letter enclosing a draft <sup>for 321<sup>99</sup>/<sub>100</sub></sup> of T. M. Kester enclosed  
by Mr Post on Bowry & Menous & Co of this city was  
received by me this morning. I presented the draft  
during the day at their counting house which was paid  
and I deposited the money in the New York Bank. This  
afternoon Mr. G. L. Yates called with the order of Mr  
Post upon me for \$223.<sup>99</sup>/<sub>100</sub> which I paid. The two other  
bills will doubtless be <sup>presented & paid</sup> in a day or two. I shall carefully  
preserve the orders as receipted, so that if desired they can  
be transmitted. — I shall be glad to hear from you at  
any time as to the state of things among you. I shall be
