CLASSICAL MEETING HELD IN HOLLAND, JUNE 29, 1859

Presidency

Art. 1. Proposed at the absence of the president of the previous meeting that the Rev. Klyn, as the eldest in years, preside over the meeting until a president is chosen. After he has prayed, the brethren proceed to the election. It appears that Dr. van Raalte has been elected who then opens the session in prayer.

Deputation to Synod

The Constitution of our church stipulates that at least one member of the synodical deputation is present for the examination. Since no one could be here, the scribe reports that the deputation of the classis Michigan has informed him that he did not need to come. Moreover, the Wisconsin deputy had intended to come. As far as the last named was concerned, unforeseen circumstances must have prevented his coming. During the discussion Mr. Chamberlain reports that even the classes of the Eastern churches, which are located so closely together, often ignore the article which stipulates the presence of a deputation when in need. After hearing this, it is resolved by the brethren

that since the request to have two deputies of the pertinent classes be present was not satisfied, and since this also indicates that classis has obeyed the stipulation of the Church Order in principle, and since the congregation in Grand Rapids should not tolerate a longer delay, that the classis proceed to the examination of brother Houbolt.

The pastors Van de Wall and Oggel, having been charged with the drafting of a concept of guidelines for examinations in the future, hand in the following report. This is approved.
