That the said parties of the first part, for and in consideration of \$85/100 Dollars to them paid by the said party of the second part, at presents do grant and convey unto the said party of the second part, and All of that certain parcel of land, described as the North E of Range Fifteen West, in the County of Ottawa and States survey, One hundred & Sixty acres. And with the said party of the second part that and they will warrant and defend the same unto the second part, his heirs and assigns forever.

with all the appurtenances and all the estate, title and interest, of the said part 1st, Eight hundred & twenty three dollars & eighty five cents Year, payable semi annually, by the tenth day of each month, promissory note bearing even date hereunto, executed by second part as a collateral security, which payments if duly made, will render this conveyance void.
