The executive committee of the Council of Hope College met with Dr. Albertus C. Van Raalte in the chair. The meeting was also attended by Pres. Philip Phelps Jr., Rev. Christiaan Vander Veen, and Rev. Abel T. Stewart. A proposition of Otto Doesburg was read. The committee resumed its meeting on 25 August. It was referred to Van Raalte to examine the lease of property to the Iron Company.

A preposition was received & read from Otto Doesburg concerning the publication of De Hope. The meeting adjourned until the next day.
