COLLECTION NOTE

This collection consists of the correspondence and papers of the Coke family of Logan County, Kentucky and several related families, principally the Guthrie and McCutchen families. A genealogical chart in Box 1, Folder 1 shows relationships among persons featured most prominently in the collection, but should not be construed as a comprehensive genealogy.

Hailed as "one of Kentucky's greatest sons," James Guthrie was a state legislator, U.S. Senator, Secretary of the Treasury, and president of the Louisville & Nashville Railroad. He led the movement to secure a charter for the University of Louisville and participated prominently in the development of the city's transportation infrastructure. In 1840, James Guthrie's daughter Mary Elizabeth Guthrie (1823-1901) married Richard Henry Coke (1815-1845). After his death, she married John Alexander Caperton (1817-1900).

Richard and Mary (Guthrie) Coke's son, James Guthrie Coke (1841-1905) and his first wife, Jennie Mary Winston (1845-1870) were the parents of James Guthrie Coke, Jr. (1866-1938), who married Carrie McCutchen (1864-1938), the daughter of Cyrus D. McCutchen (1823-1874) and Amanda S. McCarley (1830-1887). Cyrus's grandmother, Elizabeth Weir McCutchen (1756-1842), came to Logan County, Kentucky to claim land grants awarded to her late husband John McCutchen (1749-1789) for his Revolutionary War service. Elizabeth's house (believed to have been built between 1810 and 1820) and farm, which came to be known as McCutchen Meadows, remained in the family until 1980, when it was sold by the heirs of William Gaston Coke (1895-1977), the son of James Guthrie Coke and Carrie (McCutchen) Coke.

Items of interest in the collection include the following:

 Political correspondence of James Guthrie Coke, Jr., an Auburn banker and farmer who served in the Kentucky legislature and was active in the Democratic Party. His letters to wife Carrie (Box 1, Folder 7) in early 1914 take the form of "journals" in which he describes the work of the General Assembly, his impressions of other legislators, and his dismay at the power of lobbyists. When prominent Kentucky woman suffragists Laura Clay and Madeline McDowell Breckinridge address the assembly, Coke, an opponent of woman suffrage, praises their speeches but describes them in uncomplimentary terms and doubts

- that they gained support for their cause. In the 1930s, he also addresses objections over a possible conflict as he participates in political campaigns while serving as a District Governor of Rotary International (Box 1, Folder 10).
- Letters to daughters Amanda and Jennie from their parents J. Guthrie Coke, Jr. and Carrie (McCutchen) Coke (Box 1, Folders 9, 14), while they are attending school in New York and in Charlotte, North Carolina. The letters keep the sisters up to date on activities at home, including the livestock enterprises of brother Gaston (William Gaston Coke).
- Typescripts of letters from and regarding Benjamin Franklin McCutchen (Box 2, Folder 18), a brother of Cyrus D. McCutchen. He writes from Alabama during the Civil War as he attempts to gain a medical discharge from army service and enters into a partnership to make potash for the Confederate government; a letter from his partner describes the circumstances of his death and burial.
- Materials regarding McCutchen Meadows (Box 2, Folder 21), including historical data, correspondence regarding the private cemetery on the property, clippings, the 1980 auction program and supporting information, a National Register of Historic Places nomination, appraisals of household items, and interior photographs.
- Materials regarding another family property, the J. Guthrie Coke Building (also known as Caperton Block) at Fourth and Chestnut streets in Louisville, Kentucky, including clippings, a National Register of Historic Places nomination, ownership histories, exterior photographs and one interior photograph (Box 2, Folder 22).
