



A Systematic Literature Review: the Role of Teachers and Parents in Online Learning in Indonesia

Abstrak

Tujuan dari penelitian ini adalah untuk menganalisis peran guru dan orang tua selama pembelajaran online. Metode yang digunakan dalam penelitian ini adalah Systematic literature review dengan PICOS. Data yang digunakan diambil dari Sinta, Google Scholar, dan Publish or Perish. Metode yang digunakan untuk menganalisis data, kemudian menetapkan kriteria inklusi dan eksklusi. Hasil penelitian ini menemukan bahwa peran guru meliputi melakukan inovasi media pembelajaran, menyusun RPP, memberikan motivasi, menjadi fasilitator, mediator dan evaluator. Sedangkan peran orang tua meliputi menyediakan fasilitas penunjang belajar, orang tua harus dituntut untuk menguasai teknologi, mendampingi anak dalam belajar, memotivasi anak, memelihara psikologis dan spiritual anak serta peran menjadi panutan, pendampingan, pengorganisasian, dan pengajaran.

Abstract

The purpose of this study was to analyse the role of teachers and parents during online learning. The method used in this study is Systematic literature reviews with PICOS. The data used is taken from Sinta, Google Scholar, and Publish or Perish. The method used to analyse the data, then set the inclusion and exclusion criteria. The results of this study found that the teacher's role includes making innovations in learning media, preparing lesson plans, providing motivation, being a facilitator, mediator and evaluator. While the role of parents includes providing learning support facilities, parents must be required to master technology, assist children in learning, motivate children, maintain psychological and spiritual children as well as the role of modelling, mentoring, organising, and teaching.

INTRODUCTION

The impact of the COVID-19 pandemic has affected various fields of human life, one of which is in the field of education (Wong et al., 2020; Remuzzi & Remuzzi, 2020; Chang et al., 2021). The global education system has changed Volume 3 Nomor 3 Tahun 2022 11

following the emergence of the COVID-19 pandemic. Based on research by the World Health Organization (WHO), the COVID-19 pandemic is a powerful virus that can cause respiratory tract infections and severe acute respiratory syndrome in humans. This change in the education system occurred from offline to online learning, where the government temporarily closed educational facilities simultaneously to prevent the transmission of the covid-19 virus (Cahapay, 2020; Majoko & Dudu, 2020).

On the other hand, it has a negative impact, online learning also has a positive impact including students will have a lot of time to work on questions, do practice questions and parents can more easily supervise and condition the learning process and this according to some studies is seen as more effective (Hwang et al., 2022 ;Lage-Cal et al., 2020).

In conditions of online learning, the role of parents at home is very important because in online learning students carry out their learning activities at home. Parents have an obligation to accompany their children's learning process because it is to guide their children in developing cognitive and social aspects (World Health Organization, 2021; Nam & Park, 2014; Titik, 2016). The involvement of parents to assist their children in learning aims to improve learning outcomes and achievements and maintain children's learning motivation. parents must be skilled and innovative to liven up the atmosphere of playing and learning, based on research results there are only 0.9% of 39 parents who apply these rights (T. Handayani et al., 2020).

There are four ways to increase the role of parents at home in children's education, the first is to carry out educational activities regularly and not tied to homework given by teachers from school, second is to monitor children's cognitive development through their learning outcomes and achievements, third is to monitor children's cognitive development. moral development, etiquette or ethics of children so that children have good and civilized attitudes and the fourth is to analyze the effectiveness of time when learning activities in class take place (Lilawati, 2020).

In addition, the teacher also has a very important role to create a comfortable learning atmosphere and be able to maintain and arouse student learning motivation. Therefore, in online learning, it is necessary to pay attention to several important aspects including planning, knowing student needs, quality educators, interesting learning media and evaluation of learning outcomes (Kurniati et al., 2020; Pakpahan & Fitriani, 2020). In online learning, teachers have big challenges where teachers will have difficulty in making their students understand, therefore it is important for teachers to prepare learning tools such as lesson plans, learning methods, and syllabus (I. Handayani & AlFarhatan Noor Asri, 2021).

Furthermore, to make teachers ready to face challenges in online learning during this COVID-19 pandemic, at least teachers must have five skills, including, Volume 3 Nomor 3 Tahun 2022 | 12

firstly, the ability to think critically where in this ability the teacher must be able to access and analyze information. Second, problem solving skills where the teacher must be able to provide various solutions from various points of view. The three skills are communication and collaboration, these abilities include conveying ideas, ideas and information as well as cooperation in micro and macro scopes. Fourth, the ability to think creatively and innovatively, this ability is useful for a better learning process and can trigger students to think creatively and innovatively. The fifth is the ability to be technology literate and digital literacy so that teachers are able to use advances in technology and information in their learning process (Salmia & A. Muhammad Yusri, 2021).

There are many studies in Indonesia that examine the role of teachers and parents in online learning during the COVID-19 pandemic, which are written in Indonesian and English. This study aims to compare the studies that have been carried out and published so that they can make a specific conclusion. Therefore, this study has research questions which include: RQ1. What is the role of teachers and parents in online learning during the COVID-19 pandemic?; RQ2. What are the solutions and innovations and developments carried out by teachers and parents in education during the covid-19 pandemic?

The first research question is to provide a visualization of specific research related to the role of teachers and parents in online learning while the second research question aims to find a systematic relationship between the roles of teachers and parents in online learning. This article is divided into four parts, the first part discusses the role of teachers and parents in the online learning period, the second part discusses the steps in literature search and the flow of the identification, screening, eligibility and process included, the third part regarding the results and discussion, and the fourth is the conclusion.

METHODOLOGY

The method used in this study is to use a systematic literature review (SLR). A systematic literature review is a means of identifying, evaluating, and interpreting all available research relevant to a particular research question, topic area, or phenomenon of interest (Barbara Kitchenham & Charters, 2007).




Figure 1. PRISMA Prism

RESULTS AND DISCUSSION

The Role of Teacher and Parents in Online Learning

The teacher's role in online learning includes providing learning motivation to students (Wijayanti & Fauziah, 2020; Wajdi, 2021). In addition, teachers must also be able to adapt to online learning conditions, therefore, mastery of learning technology is highly demanded to be mastered by teachers (I. Handayani & AlFarhatan Noor Asri, 2021; Agaton & Cueto, 2021; Pertiwi et al., 2021). Teachers also act as demonstrators, mediators, facilitators and evaluators in the online learning process (Cahyani et al., 2021). Before the teacher starts learning, the first step that must be prepared well is to prepare learning tools carefully and adapt to online learning conditions (Hajeni, 2022).

The role of parents in online learning situations is to provide children with learning support facilities, such as mobile phones, quotas, laptops and other supporting facilities (Kurniati et al., 2020; Iftitah & Anawaty, 2020). Fulfillment of children's learning support facilities at home is influenced by parents' financial factors. In accompanying their children during online learning, parents have a role to maintain and pay attention to children's lifestyles so that during online learning activities children stay healthy (Kurniati et al., 2020) physically, spiritual (Cahyani et al., 2021) and psychological (Agusriani & Fauziddin, 2021).

CONCLUSION

Teachers and parents have an important role when learning online. Teachers and parents must be ready to accompany students when in class and outside the classroom, provide motivation, apply learning innovations will be able to maintain and increase children's learning motivation. In addition, spiritual and psychological guidance for children is able to make children calm and enjoy the learning process.
