Overview

Scope Notes

Course catalog description: "The legal, regulatory, and ethical environment in which business operates is explored, with emphasis on the regulation of business, international law, environmental law, ethics, the political and social factors influencing case and statutory law, contracts, employment law, and business organizations."

This course is an introduction to business law; concepts such as the American legal system, international law, ethics, corporate social responsibility, crimes and torts, contracts, corporate governance, government regulation, employment law, and other foundational concepts should be robustly covered by any OER materials. Current textbooks in use have ample bundled ancillaries, and faculty have indicated that having such materials readily available is important to them.

This search consulted OER Commons, Open Textbook Library, OpenStax, Merlot, BC Campus, Rebus Community, and Pressbooks. Many of the textbooks found were from the same 2012 set of Creative Commons textbooks; these texts are no longer being freely updated by their original author(s).

Gap Analysis

There are many textbooks available on introductory business law, but few of them have ancillary materials (i.e. quiz banks, discussion activities, etc.). There is, generally speaking, a dearth of bundled supplemental materials within the current OER.

- Comments: A generally well-reviewed OpenStax textbook, with some small critiques of specific details that would need correcting by an instructor, which can easily be done via Google Docs. Reviews agree that the text needs some supplementing, and hope for a *Business Law Essentials II* to be published at some point to help fill in the gaps, but so far no such text has been forthcoming. Like other OpenStax textbooks, it includes a quiz bank and Blackboard course package.

This textbook was written and published by the same individuals as *Business Law and the Legal Environment*, so the two texts could likely easily be used to supplement each other.

It is unclear exactly what the differences are between this textbook and *Business Law and the Legal Environment*; differences definitely exist, however, as their chapter headings are not identical.
