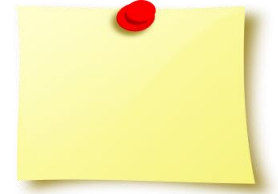

- The synergy between academy and practice – pracademic symbiosis
- Aim is to prepare students for practice
- Criminal Investigation is a process - based on investigative doctrine grounded in theory and practice
- Content of Criminal Investigation modules delivers knowledge and application
- Threshold concepts
- Simulated based learning (SBL) – application of knowledge that promotes learning
- Desk Top Exercises and Semester-long investigation – grounded in real-world practice and prepare for assessment

- Critical analysis and ethical decision-making



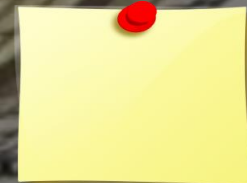
