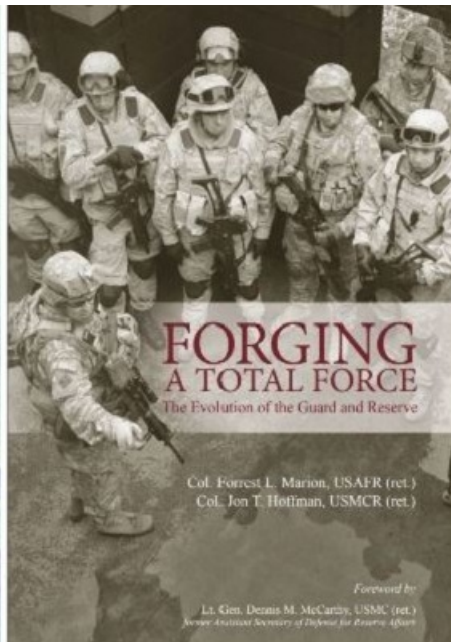
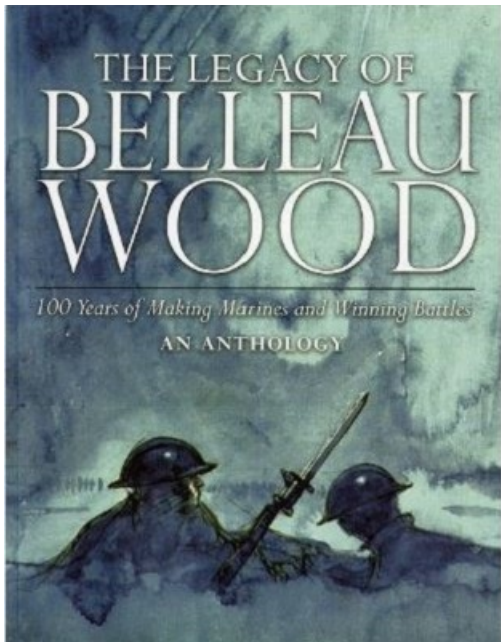

### Virtual Currency: Financial Innovation and National Security Implications

What, if any, regulatory structure exists around these emergency forms of currency and technology? Does the notion of peer-to-peer sharing provide an increased veil of secrecy that could be exploited by terrorists and illicit actors?
