Faculty OER survey questions

Definitions:

Open Educational Resources (OER): OER are defined as "teaching, learning, and research resources that reside in the public domain or have been released under an intellectual property license that permits their free use and repurposing by others." Unlike traditionally copyrighted materials, these resources are available for "open" use, which means users can edit, modify, customize and share them. This means that all students in a class have access to no- or low-cost learning materials on the first day of class. (https://www.hewlett.org/strategy/open-educational-resources/)

Open Textbooks: Open Textbooks are textbooks that are freely available with non-restrictive licenses. Covering a wide range of disciplines, Open Textbooks are available to download and print in various file formats from several websites and OER repositories. This means that all students in a class have access to no- or low-cost textbooks on the first day of class. (https://open.umn.edu/opentextbooks/)

Creative Commons Licenses: These are licenses that allow various types of reproduction, distribution and re-mixing (sometimes with specific exclusions) without fee or restriction (https://creativecommons.org/licenses/)

Public Domain Resources: The term "public domain" refers to creative materials that are not protected by intellectual property laws such as copyright, trademark, or patent laws. The public owns these works, not an individual author or artist. Anyone can use a public domain work without obtaining permission, but no one can ever own it.
