## **CONTRIBUTOR'S AGREEMENT**

Agreement between the Publisher, the Editors, and the Contributor for the publication of an article or essay or audio/video (the "Contribution") by the University of Regina Press

The University of Regina Press (the "Publisher") has agreed to publish your Contribution as part of a collection of essays or articles or audio/video (the "Work"). The agreement is contingent upon the fulfillment of the requirements listed below:

- 1. The Contributor warrants that the Contribution is original, that it is not in any way libellous or unlawful, and that it does not infringe any copyright or other proprietary right. The Contributor further warrants that she or he holds the rights to publish and sell the article or essay in all traditional forms and formats, including cloth (hardback) and paperback, and all other formats, including but not limited to ebooks, PDFs, audio/video, and mediums not yet invented.
- 2. By submitting the Contribution, you agree to transfer copyright to the Publisher, including rights to publish and sell the Contribution in any binding or medium, including but not limited to print, digital, audio/video, and mediums not yet invented, and all related rights necessary for the full use and enjoyment of such right of publications. After publication, if the Contribution is re-printed or distributed or licensed for fee, you will receive a proportion of 50% of any payment to the Publisher, divided equally amongst the total number of contributors whose work was licensed in a specific agreement.
- 3. The Contributor warrants that the Contribution has not been published elsewhere, and that if it has been previously published, the Contributor agrees to notify both the Editors and the Publisher and to obtain and provide written consent to re-publish before the Contributor submits the Contribution to the Editors.
- 4. The Contributor agrees to the Publisher's policy which determines the number of complimentary copies of the Work to which the Contributor is eligible, if any. For this Work, the Contributor will receive one (1) complimentary copy.
- 5. Upon publication of the Work inclusive of the Contribution, the Contributor may purchase additional copies of the Work at a discount of 40%. The Contributor is responsible for all shipping and customs charges related to said purchases.
- 6. The Contributor agrees to make a reasonable effort to conform to the Publisher's submission guidelines and to liaise with the Editors to ensure that the requirements of these guidelines are met to a reasonable degree in submitting the Contribution.
