1 Introduction

The SASTDES Destination Carbon Footprint Tool was developed by the Centre for Sustainability, Tourism and Transport of Breda University of Applied Sciences as part of the SASTDES-project (Smart Assessment Sustainable Tourist Destinations). The project is cofunded by the Taskforce for Applied Research (SIA), part of the Netherlands Organisation for Scientific Research (NWO), under the RAAK scheme.

1.1 Purpose

The model's scope is for European Destinations. The model calculates the carbon footprint of the visitors to your destination based on the choice of transport modes from the source markets to the destination, the number of nights and shares of a range of accommodation types and a range of tourism activities. Results are provided for the carbon footprints per source market and divided over transport, accommodation, and activities.
