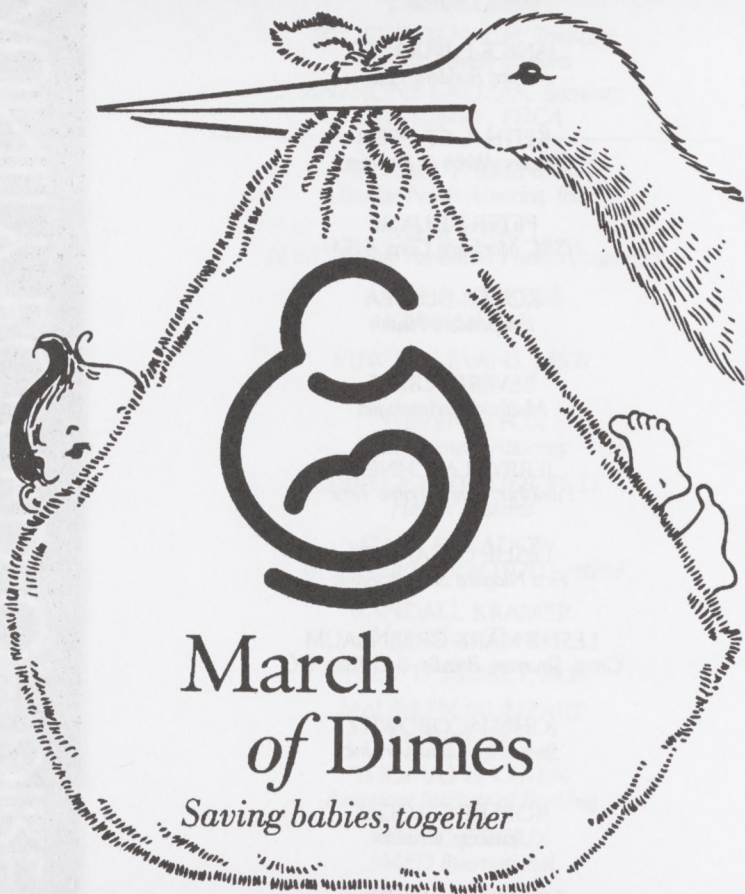



## Director's Note...

*My Way: A Musical Tribute to Frank Sinatra* was first presented at Artpark at the Church in Lewiston in 1999. The show featured songs made famous by Frank Sinatra and was set at a high school reunion. For its subsequent sold-out production at Tennessee Repertory Theatre, the high school reunion setting was dropped and the music and lyrics were presented in more of a nightclub environment. This version was then presented, once again with sold-out results, this past May at the Asolo Theatre in Sarasota, Florida. The show is now booked in over twenty five theatres across the nation in the next two years.

John Fredo, who is an actor and the choreographer for our production, has been featured in all of the productions to date of *My Way*. I want to thank John for his commitment to the project and his wonderful creativity and collaborative spirit. Truth be told, John's choreography and musical staging has created the essence of our production. Other than the occasional observation or suggestion, my contribution has mostly been playing the wonderful swing music that Sinatra performed. And, for that opportunity, I want to thank the *My Way* creators David Grapes and Todd Olson, for preserving the swing style of the music and not trying to "musical theatre" it. It is a rare treat indeed to come to the theatre and hear this kind of music performed. Finally, I want to give a huge thank you to our staff, designers and ADF Construction Corp. for making this production possible. Due to opening deadlines, everyone had to finish their last few weeks of work in around half the normal time. Now, we in the theatre are used to these insane timetables, but what really amazed me was the way Joe, Nick, Rob and the rest of the ADF guys jumped right in. Without everyone's extraordinary effort, we wouldn't be here today. Thanks.
