INTRODUCTION

In the whirlwind year of 2021, reproductive health, rights, and justice have faced

unprecedented threats. Texas implemented a six-week abortion ban, cutting off access to abortion for the vast majority of people in the nation's second most populous state. The Supreme Court's monthslong failure to block the Texas abortion ban serves as an ominous prelude to its upcoming decision in *Dobbs v. Jackson Women's Health* Organization, a case from Mississippi that presents a direct threat to the right to access abortion which has existed since the *Roe v. Wade* decision in 1973.

Against this bleak backdrop, there is an urgent need for states to protect and advance access to reproductive health care. While in 2020, state legislatures ground to a halt at the height of the pandemic, **in 2021 they resumed their pre-pandemic momentum, passing laws to advance reproductive freedom in multiple areas**.

AS OF DECEMBER 1, 2021




In 2021, state legislatures introduced at least 1,096 proactive health, rights, and justice bills and resolutions, with 36 states passing at least one proactive bill to address these issues. The trends of 2021 state legislation track with the National Institute for Reproductive Health's core 2021 priorities: to pass laws that will protect and expand access to abortion, improve access to contraception, and address racial disparities in maternal health. For example, nine states passed legislation to solidify abortion rights and expand access to care. Ten states increased access to contraception by allowing pharmacists to prescribe or administer contraceptives directly to patients, and/or allowing a full year's supply to be dispensed at a time. Ten states passed bills that attempt to address racial disparities in maternal health. These advances and others are expanding reproductive freedom and access to care when they are needed most.

This report, which NIRH has released annually since 2014, provides a summary and synthesis of the year's proactive state policy work on reproductive health, rights, and justice. It canvasses proactive state-level policy across the areas of abortion, contraception, pregnancy, parenting, menstrual equity, sexuality education, and combating reproductive coercion. NIRH hopes that this report provides information and inspiration to state-level advocates and lawmakers who are seeking to address the momentous reproductive health policy challenges facing people across the country. And NIRH looks forward to working with state advocates in 2022 to pass even more proactive legislation.



EXPANDING ACCESS TO ABORTION CARE

A substantial majority of people in this country believe that abortion should be legal in all or most cases.¹ Even in Texas, which is considered a conservative state, more than 80% of people oppose a total ban on abortion.² While much of the current discourse is focused on abortion bans, the reality is that access to abortion is a right in name only for many people, including those who live in states that have not passed bans. In the last decade alone, states have enacted more than 550 abortion restrictions.³ Additionally, the COVID-19 pandemic worsened pre-existing difficulties in accessing care. A 2020 survey found that one-third of reproductive-aged women⁴ had experienced a cancellation or delay of reproductive health care, and the rate was especially high among Black and Latinx women.⁵





Preventing or delaying people from accessing abortion care causes harm. A multi-year study found that, compared to women who were able to access abortion care, women who sought abortion but were denied care were:

- 1) four times more likely to live below the federal poverty level;
- 2) more likely to experience serious complications like eclampsia and postpartum hemorrhage;
- 3) more likely to remain with abusive partners;
- 4) more likely to experience short-term anxiety and loss of self-esteem after being denied an abortion; and
- 5) less likely to have aspirational life plans over the next year.⁶

Some legislators — encouraged by the substantial efforts made by advocates across the country — are attempting to protect and expand abortion access. Nine states passed proactive abortion legislation in 2021; in a tenth, Illinois, both chambers have voted in favor of legislation that repeals anti-abortion restrictions aimed at minors, which the governor is expected to sign (House Bill 370). At the federal level, the House of Representatives passed a budget without the Hyde Amendment, which for decades has denied insurance coverage of abortion to people eligible for Medicaid and other government-sponsored health insurance. The Women's Health Protection Act, which would create a statutory right for health care providers to provide abortion care and a corresponding right for their patients to receive that care free from medically unnecessary restrictions, also passed the House.

27 states introduced proactive abortion legislation in 2021.



At the state level, several states passed legislation that will make it easier for people to access abortion care.

- **Colorado's** constitution prohibits Medicaid coverage of abortions; even exceptions to that general rule include medically unnecessary restrictions, such as a requirement that these abortions be provided only by physicians and in a particular type of facility. In 2021, Colorado repealed those additional restrictions, although the constitutional coverage limitation remains (Senate Bill 142).
- Hawaii expanded access to abortion care by authorizing qualified advanced practice registered nurses to perform first-trimester abortions (House Bill 576).
- **Virginia** repealed a state law prohibiting the inclusion of abortion coverage in private health insurance plans (House Bill 1896 / Senate Bill 1276).
- And **Washington** extended its general requirement that insurance plans that provide maternity care also cover abortion to apply to student health plans (House Bill 1009).

Two states passed legislation **decriminalizing abortion**.


- **Delaware** removed abortion from its criminal code and eliminated the provisions of its law that treated abortion differently from other medical procedures (House Bill 31).
- New Mexico repealed a 1969 law that criminalized abortion (Senate Bill 10). This law had been dormant since *Roe v. Wade*, and its repeal ensures that it cannot be used to threaten New Mexico providers and their patients if abortion rights are further weakened or overturned in the future.



States also enacted other types of proactive measures.


- California prohibited various behaviors that intimidate and threaten reproductive health patients and providers, and it required law enforcement agencies to report the number of calls for help and arrests originating from anti-abortion crimes (Assembly Bill 1356). California also passed a resolution urging President Biden and Congress to express their support for every person's fundamental right to control their own reproductive decisions and access comprehensive reproductive health care (House Resolution 10 / Senate Resolution 6).
- Connecticut prohibited crisis pregnancy centers from engaging in deceptive advertising that would mislead people seeking abortions, and it empowered the Attorney General's office to pursue remedies if the law is violated (Senate Bill 835).
- **Oregon** created a system whereby mergers involving large hospitals and insurers that could result in a loss of reproductive health care, including abortion, may trigger an in-depth review by the state and a stakeholder board (House Bill 2362).
- Finally, **Virginia** commissioned a review of the reproductive healthcare services, including abortion, that are provided to incarcerated pregnant people (Senate Bill 1300).

Virginia repealed a state law prohibiting the inclusion of abortion coverage in private health insurance plans.






IMPROVING ACCESS TO CONTRACEPTION

Access to contraception has been key to gender equality over the past decades. The

Institute for Women's Policy Research found that access to contraception has led to higher education rates, increased the number of women in the workforce, and reduced the probability that young women will live in poverty.⁷ Coverage of contraceptives is cost effective and reduces rates of unintended pregnancy.⁸ Yet more than 19 million American women of reproductive age live in contraceptive deserts, meaning that their county lacks reasonable access to a health center that offers the full range of contraceptive methods.⁹ States are taking various measures to improve the availability of contraception.





In 2021, multiple states passed legislation allowing pharmacists to prescribe or administer contraceptives directly to patients: Arkansas (House Bill 1069), Arizona (Senate Bill 1082), Delaware (Senate Bill 105), Illinois (House Bill 135), Maryland (House Bill 135 / Senate Bill 84), Nevada (Senate Bill 190), North Carolina (House Bill 96), and Utah (House Bill 178).

Other legislation ensured that people can receive a year's supply of contraceptives at one time.

- **Colorado** established a program that provides eligible patients a one-year supply of contraceptives regardless of gender, citizenship, or immigration status (Senate Bill 9).
- The same **Illinois** bill that allowed for pharmacist-prescribed contraceptives also permitted the dispensing of a year's supply (House Bill 135).
- Virginia enabled individuals covered by Medicaid and its Family Access to Medical Insurance Security program to receive a one-year supply of contraceptives (Senate Bill 1227).

Other proactive legislation regarding contraception moved forward as well.


- **Colorado** required health insurance plans to cover contraception, as well as counseling, prevention, screening, and treatment for sexually transmitted infections, with no out-of-pocket costs (Senate Bill 16); it also sought federal authorization to expand Medicaid coverage of family planning services (Senate Bill 25).
- **Delaware** required the Victims' Compensation Fund to cover the cost of emergency contraception (among other costs) for survivors of sexual offenses (House Bill 182), and
- Nevada required medical facilities to inform survivors of the availability of emergency contraception and provide it upon request (Senate Bill 364).
- Finally, **Utah** required jails to provide incarcerated people with the option of continuing medically prescribed contraception (House Bill 102).








INCREASING ACCESS TO PREGNANCY CARE

The tragically high rate of maternal mortality in the United States continues to grow, and at higher rates for women of color than for white women.¹⁰ The maternal death ratio for Black women is more than twice the ratio for white women.¹¹ Several states passed legislation attempting to address unacceptably high rates of maternal mortality, and many of these states explicitly tackled racial disparities.



ACCESS TO PREGNANCY CARE

California (Senate Bill 65), Connecticut (Senate Bill 1), North Dakota (House Bill 1205), and New Mexico (Senate Bill 96) all created committees to review data on maternal mortality and make recommendations to assist in reducing it; many of these committees were explicitly directed to look at racial disparities in care. Indiana expanded the scope of fatalities that its statewide maternal mortality review committee must examine (Senate Bill 10). Kentucky required its Department of Public Health to complete an annual report that includes racial, income, and geographic information about the incidence and causes of child and maternal fatalities and make recommendations for action (House Bill 212). Louisiana directed its Department of Health to analyze determinants of health equity that influence racial health disparities among women, as well as interventions that positively impact those disparities (Senate Bill 133). Maine required an existing commission to study the extent of disparities in access to prenatal care for the state's racial, indigenous, and tribal populations and make recommendations to resolve them (Senate Bill 376); Nevada gave similar instructions to its existing Maternal Mortality Review Committee (Assembly Bill 119). New Jersey ordered birthing centers and hospitals that provide inpatient maternity services to create and implement bias training programs for staff (Senate Bill 703).

Quality reproductive health care should be not only available but culturally competent and community-based. Increased access to and insurance coverage of midwifery and doula services have been shown to particularly improve health outcomes.¹² To that end, multiple states passed legislation to **increase access to midwifery and doula care**.

- Arizona created a process and set standards for becoming a state-certified doula (Senate Bill 1181).
- Arkansas granted certified nurse-midwives greater practice authority (House Bill 1215).
- As part of its Momnibus Act, California enacted the Midwifery Workforce Training Act, which aims to
 increase the number of students receiving quality midwifery training, and convened a workgroup to
 examine the implementation of doula coverage for Medi-Cal recipients (Senate Bill 65).



- **Colorado** required insurance carriers to reimburse providers who offer healthcare services related to labor and delivery within their scope of practice, reducing barriers for midwife and doula reimbursement (Senate Bill 194).
- **Connecticut** defined doulas in statute and commissioned a study to determine whether its Department of Public Health should establish a state certification process (Senate Bill 1).
- Louisiana required health coverage plans to provide benefits for maternity services performed by certified midwives and created criteria for certifying doulas (House Bill 190). Maine required insurers to cover services performed by certified midwives (Senate Bill 239).
- **Maryland** established a licensing and regulatory system for the practice of midwifery (House Bill 758 / Senate Bill 684).
- Nevada provided for doula coverage for Medicaid recipients (Senate Bill 420).
- Rhode Island passed a bill requiring private insurers to cover doula care (House Bill 5929 / Senate Bill 484); an accompanying budget item provided for Medicaid coverage.
- Virginia directed its Boards of Medicine and Nursing to establish criteria for the licensure of certified midwives (House Bill 1953 / Senate Bill 1320), made it easier for certified nurse-midwives who meet certain criteria to practice (House Bill 1817), and authorized doula coverage for Medicaid enrollees (House Bill 1800).

Rhode Island passed a bill requiring private insurers to cover doula care and an accompanying budget item provided for Medicaid coverage.






• Pending federal approval, **Washington, D.C.** also authorized reimbursement of doula care through Medicaid, the DC HealthCare Alliance, and the Immigrant Children's Program (D.C. Bill 285).

States also attempted to improve access to reproductive health care for incarcerated pregnant people.

- Arizona restricted the use of body cavity searches and restrictive housing for pregnant people and required that pregnancy-specific training be provided to correctional employees who interact with pregnant people (Senate Bill 1849).
- **Arkansas** prohibited the placement of pregnant and recently postpartum detainees in solitary confinement or restrictive housing (House Bill 1470).
- **Colorado** required correctional facilities to develop policies ensuring that pregnant people receive safe and respectful treatment, a trauma-informed standard of care, and access to relevant health care (Senate Bill 193).
- **Kentucky** passed a bill prohibiting the placement of pregnant and immediately postpartum people in restrictive housing or solitary confinement; it also required detention facilities to provide information about community-based programs serving pregnant and postpartum incarcerated people (Senate Bill 84).
- **Minnesota** empowered its commissioner of corrections to conditionally release pregnant and postpartum people up to one year post-birth (Senate Bill 1315).
- Further, **Mississippi** limited the use of restraints, body cavity searches, and restrictive housing punishments for pregnant and postpartum incarcerated women (House Bill 196).
- **New York** ensured that incarcerated pregnant people are informed of their rights to pregnancy counseling and abortion and permitted them to have a support person present in the delivery room (Senate Bill 399).



ACCESS TO PREGNANCY CARE

- **Oregon** established a Task Force on Corrections Medical Care in response to reports that incarcerated people lack meaningful access to comprehensive reproductive health care (House Bill 3035).
- **Texas** required that an obstetrician or gynecologist and a mental health professional be made available to incarcerated survivors of physical assault, sexual assault, or miscarriage (House Bill 1307).

Three states specifically focused on maternal mental health.

- Arizona established a committee to recommend improvements for screening and treating maternal mental health disorders (Senate Bill 1011).
- **California** specified that providers of prenatal and postpartum care must ensure that mothers are offered appropriate screening for maternal mental health conditions (Assembly Bill 1477).
- **New Jersey** directed its Department of Health to identify and take steps to secure federal funding sources to support maternal mental health (Senate Bill 890).

Two other states focused on telehealth.

• Florida established telehealth maternity care pilot programs for racial and ethnic minorities in two counties (House Bill 1381).

Three states passed legislation specifically focused on **maternal mental health:**






• **Virginia** required its state medical assistance plan to provide for payment for telemedicine patient monitoring services for high-risk patients, explicitly including high-risk pregnant patients (House Bill 1987 / Senate Bill 1338).

An additional three states passed measures related to infertility.

- Illinois prohibited insurers from imposing any limitations or restrictions on fertility coverage that are different from those imposed on other prescription medications (House Bill 3709).
- **New York** added reproductive health conditions that affect female fertility to its healthcare and wellness education and outreach program (Assembly Bill 5979).
- Utah added an additional three years of coverage to its infertility treatment coverage pilot program (Senate Bill 19).

States also passed other types of measures aimed at **improving pregnancy care and creating other accommodations and protections for pregnant people.**

- **Arkansas** required healthcare providers to screen pregnant people for hepatitis C and mandated that such screenings be covered by insurance (House Bill 1136).
- Illinois required birthing centers to obtain licenses and increased the number of licenses available (House Bill 3995 and House Bill 738); it also required employers to provide all employees who are eligible for insurance coverage with a written list of covered benefits that is easily comparable to the list of benefits required by the state (Senate Bill 1905). The state also ensured that people in their third trimester of pregnancy can use disability parking (House Bill 3027) and required school boards to adopt policies related to absences and missed homework resulting from student pregnancies (House Bill 3272).



ACCESS TO PREGNANCY CARE

- Maryland mandated that an existing fund prioritize grants to federally qualified health centers in high-risk communities and centers that propose programs to increase accessibility to prenatal care in underserved communities (House Bill 1349 / Senate Bill 777).
- New York added preeclampsia information to its healthcare and wellness education and outreach program (Senate Bill 3474). Additionally, New York required hospitals to adopt protocols for management of pre-term labor and provide information to pre-term labor patients on the risks of pre-term labor (Senate Bill 1303).
- **Tennessee** directed certain state agencies to apply for funds to develop substance use recovery programs for pregnant and parenting people (Senate Bill 574).
- Texas created a program to address hyperemesis gravidarum (Senate Bill 1941).
- Vermont expanded the state's publicly funded healthcare program to cover income-eligible pregnant people and children regardless of immigration status (House Bill 430).
- Virginia established a task force on maternal health generally (House Bill 2111).
- Washington clarified that healthcare entities shall not prohibit providers acting in good faith from providing healthcare services related to pregnancy complications, including miscarriage management (Senate Bill 5140).

Tennessee directed state agencies to apply for funds to develop substance use recovery programs for pregnant and parenting people.

SENATE BILL






Many states passed **proactive resolutions regarding maternal health**. Three states — **California** (House Resolution 11), **Delaware** (Senate Concurrent Resolution 4), and **Louisiana** (House Resolution 59) — passed general resolutions aimed at maternal health awareness. Others passed resolutions specifically in support of **improving Black maternal health**, including **Delaware** (House Concurrent Resolution 18), **Illinois** (House Resolution 219), **Michigan** (Senate Resolution 39), **Rhode Island** (House Resolution 6243 / Senate Resolution 821), and **South Carolina** (House Resolution 4209). **California** (Assembly Concurrent Resolution 75) and **Delaware** (Senate Concurrent Resolution 35) also passed resolutions specifically regarding maternal mental health.


Finally, states passed other **proactive resolutions regarding pregnancy-related care**.

- Illinois recognized Pregnancy and Infant Loss Awareness Day (House Resolution 491).
- Louisiana passed a resolution requesting its Public Health Institute to study the reproductive health of incarcerated women, including maternal mortality, availability of resources, and prenatal and postpartum care and treatment (House Concurrent Resolution 85). The state also requested its Department of Insurance to create a task force to study the causes of infertility and the feasibility of mandating insurance coverage for fertility treatment (Senate Resolution 97).
- **Rhode Island** (House Resolution 6232) and **Tennessee** (House Joint Resolution 4) passed resolutions recognizing doulas.







SUPPORTING PARENTS AND FAMILIES

The COVID-19 pandemic has had noticeable negative health impacts on parents, particularly Black and Hispanic parents, those with limited financial resources, and those whose household has experienced work disruption due to childcare needs.¹³ Women, particularly women of color, have faced a greater caregiving burden and greater job losses than men.¹⁴ Additional support, including but not limited to that in the area of reproductive health care, can only help parents and families.



SUPPORTING FAMILIES

As discussed in the prior section, the United States is facing a maternal mortality crisis, the impacts of which are chiefly felt by low-income people and people of color. Experts agree that expanding postpartum insurance care is an important part of combating that crisis.¹⁵ In 2021, many states passed legislation expanding postpartum health care. In particular, several expanded the availability of **postpartum insurance coverage**.

- Colorado requested an amendment to its state medical assistance plan to provide 12 months of postpartum medical benefits to people who qualified while pregnant (Senate Bill 194).
- Florida extended its postpartum Medicaid eligibility to 12 months (Senate Bill 2518).
- Illinois expanded its health programs to serve high-risk individuals throughout pregnancy and 12 months postpartum (Senate Bill 967).
- Louisiana passed a resolution in support of Medicaid expansion to 12 months postpartum (House Resolution 193 / Senate Resolution 208).
- Maine asked for federal approval to implement phased increases for eligibility for Maine Care up to 12 months postpartum for women whose families live at or below 200% of the poverty line (Senate Bill 114).
- **Maryland** required its Medical Assistance Program to provide healthcare services that extend to one year postpartum for eligible pregnant women whose family income is at or below 250% of the poverty line (Senate Bill 923).

Several states expanded the availability of **postpartum insurance coverage**.





- **Minnesota** extended its medical assistance coverage to 12 months postpartum pending federal approval (House Bill 33a).
- Texas extended Medicaid benefits to eligible women for six months following delivery or miscarriage (House Bill 133).
- Washington also took steps to lengthen Medicaid coverage to 12 months postpartum (Senate Bill 5068), as did West Virginia (House Bill 2266).

Another way to help parents and families is to implement or expand paid family leave. Providing paid leave improves maternal health and household economic security, strengthens worker retention and productivity, and contributes to healthy growth and development for young children.¹⁶ In 2021, several states passed **proactive legislation regarding paid leave**.

- Hawaii passed a resolution requesting the convening of a task force to study, design, and develop a paid family leave pilot program (House Resolution 86).
- Louisiana also passed a resolution creating a task force to study the implementation of a paid family and medical leave program (House Resolution 118).
- **Oregon** amended its law to allow employees to take leave to care for children who require home care due to school or childcare closure resulting from a public health emergency (House Bill 2474).
- **Rhode Island** increased temporary caregiver benefits for employees who are bonding with a newborn, foster child, or adopted child, or who are caring for a child with a serious health condition (House Bill 6090).

Texas created a pool that state employees can use to transfer accrued sick or vacation leave to other employees who need it for the birth, fostering, or adoption of a child, or for other caregiving needs (House Bill 2063). **Virginia** asked its



State Corporation Commission's Bureau of Insurance to make recommendations regarding any necessary statutory changes that would help private insurance plans coexist as part of a statewide paid family and medical leave program (Senate Bill 1219). Washington, D.C. made bereavement leave available to any District employee dealing with a stillbirth (D.C. Bill 51, D.C. Bill 52, D.C. Bill 287, D.C. Resolution 63, D.C. Resolution 273). Washington
State expanded paid leave coverage to employees who lost it due to pandemic-caused
inability to meet threshold requirements for the number of hours worked (House Bill
1073); it also extended job protection and health benefits to any employee who has
been on the job for 90 days (from a previous requirement of 12 months on the job)
and expanded the definition of "family member" to accommodate more caretaking
relationships (Senate Bill 5097).

The World Health Organization and the United Nations International Children's Emergency Fund (UNICEF) recommend that children be breastfed for the first six months of life,¹⁷ yet parents who wish to breastfeed often lack support. Several states passed legislation to **help breastfeeding parents**.

- **Arkansas** created a breast milk bank and an accompanying fund to help pay for users' expenses (House Bill 1067).
- **California** created Breastfeeding Awareness Month (Senate Concurrent Resolution 55).
- **Connecticut** required all employers to make reasonable efforts to provide adequately equipped lactation spaces that are free from intrusion and shielded from the public (House Bill 5158).

Several states passed legislation to **help breastfeeding parents,** including:





- North Dakota clarified that breastfeeding may occur in any location, removing its prior requirement that breastfeeding be done in a "discreet and modest manner" (House Bill 1105).
- New York commissioned a review, report, and recommendations on racial and ethnic disparities in breastfeeding rates and barriers to successful breastfeeding (Senate Bill 1296).


Finally, some states passed other types of measures.

- **Arizona** mandated that incarcerated parents be placed in facilities relatively close to their children and provided opportunities for frequent visitation to the greatest extent possible (Senate Bill 1849).
- Hawaii passed a resolution urging the federal government to amend its policies related to postpartum sterilization waiting periods for Medicaid recipients (Senate Concurrent Resolution 191).
- **Maryland** required the establishment of a model policy that supports and improves the educational outcomes of pregnant and parenting students (Senate Bill 438).
- **Minnesota** created a grant program for home visiting programs serving pregnant women or families with young children (House Bill 2128).
- Montana put in place a program to ensure that women who give their children up for adoption receive a list of state mental health resources and are notified of the availability of pre- and postnatal outpatient mental health services (House Bill 208).
- New Jersey established a newborn home nurse visitation program (Senate Bill 690).







PROMOTING COMPREHENSIVE SEXUAL EDUCATION FOR YOUNG PEOPLE

All young people should be given the information necessary to make their own healthy choices about sexual behavior, sexuality, and relationships. Comprehensive sex education has been shown to generate numerous positive outcomes for young people, including increased usage of contraception.¹⁸ It reduces the incidence of sexual risk behaviors, sexually transmitted infections, and adolescent pregnancy, and it encourages adolescents to have more egalitarian relationships and mindsets.¹⁹ Comprehensive sex education is supported by organizations such as the United Nations Educational, Scientific, and Cultural Organization (UNESCO)²⁰ and the American College of Obstetricians and Gynecologists.²¹



- Although Alabama does not mandate teaching of sex education in public schools, it passed legislation requiring sex education to be "medically accurate" when offered and removed outdated and harmful language about sexuality from the sex education provision of its Code (House Bill 385).
- **California** passed a bill requiring social workers and probation officers to include information in their juvenile court reports about whether youth are receiving comprehensive sexual health education (Assembly Bill 153).
- Illinois passed a resolution recognizing every student's right to comprehensive sex education (House Resolution 39). It also passed legislation requiring its State Board of Education to develop and adopt voluntary learning standards for comprehensive personal health and safety education for students in kindergarten through fifth grade and comprehensive sexual health education for students in sixth through twelfth grade (Senate Bill 818), and it specifically required age-appropriate lessons on sexting to be incorporated into the curriculum beginning in sixth grade (House Bill 24).

Alabama passed legislation requiring sex education to be "medically accurate".



AS OF DECEMBER 1, 2021








Nearly 22 million American women live in poverty, and many cannot afford menstrual

products.²² Many people in poverty have also experienced pandemic-induced shortages in the supply of menstrual products.²³ For minors in particular, lack of menstrual products and support for periods can lead to lost educational opportunities.²⁴ Many states are attempting to address these problems through legislation.



Several states passed legislation that will **increase the availability of free menstrual products to students in public** schools and universities: Alabama (House Resolution 262), Arkansas (House Bill 1611), California (Assembly Bill 367), Colorado (Senate Bill 255), Delaware (House Bill 20), Illinois (House Bill 641), Maryland (House Bill 205 / Senate Bill 427), Nevada (Assembly Bill 224), Oregon (House Bill 3294), Rhode Island (House Bill 5083 / Senate Bill 86), and Washington (House Bill 1273).

Illinois passed legislation indicating its intention to apply for a waiver to permit public benefits recipients to use their benefits to purchase menstrual hygiene products if the federal government makes such a waiver available (House Bill 155). The state also passed legislation requiring homeless shelters that provide housing to women or youth to make menstrual hygiene products available free of charge (House Bill 310) and revised the language of its laws to refer to "menstrual hygiene products" instead of "feminine hygiene products" (House Bill 156). Further, Louisiana (House Bill 7), Maine (House Bill 156), Michigan (House Bill 5267, Senate Bill 153), and Vermont (House Bill 436) created state sales and use tax exemptions for menstrual hygiene products.

Additional states passed other legislation that advances menstrual equity.


- Maryland created a state income tax subtraction of up to \$1,000 for donations of menstrual hygiene products (House Bill 711 / Senate Bill 622).
- Missouri required menstrual hygiene products to be made available to incarcerated people (Senate Bill 53).
- Maine (Senate Bill 304) and Tennessee (Senate Bill 974) specified that good faith donors of menstrual hygiene products, as well as organizations that receive and distribute menstrual hygiene products, cannot be held liable for damages resulting from the products' condition if they were apparently usable when donated or received and distributed.

AS OF DECEMBER 1, 2021








PROHIBITING COERCION IN REPRODUCTIVE HEALTH

Patients' autonomy should be at the center of reproductive health care. Several states outlawed coercion and mandated informed consent in reproductive health care this year. Experts and the broader public have condemned the practice wherein teaching hospitals allow medical students to perform pelvic examination.²⁵




To that end, several states passed legislation in 2021 protecting patients from having pelvic examinations performed on them while they are unconscious or anesthetized without prior written consent: **Arkansas** (House Bill 1137), **Arizona** (Senate Bill 1017), **Nevada** (Senate Bill 196), **Rhode Island** (House Bill 5544 / Senate Bill 996), and **Texas** (House Bill 1434).

New York passed a law requiring its Department of Health to develop an informational pamphlet describing the proper procedure for pelvic examinations, which medical practitioners will be required to disseminate to patients who are undergoing pelvic examinations (Senate Bill 210).

Some states passed other bills prohibiting coercion in reproductive health.


- Arizona codified civil fertility treatment fraud (i.e., the misuse or unauthorized use of reproductive material in assisted reproduction) as unlawful (Senate Bill 1237).
- **Arkansas** codified a criminal offense of fertility treatment abuse and a civil offense of fertility treatment fraud (Senate Bill 474).
- **California** clarified that nonconsensual removal of a condom is sexual battery (Assembly Bill 453) and modified the definition of "disturbing the peace" for protective order purposes to include reproductive coercion (Senate Bill 374).

Many states passed resolutions **prohibiting coercion in reproductive health,** including:

LOOKING FORWARD

While the proactive developments discussed in this report are heartening, 2022 will almost certainly bring further rollbacks in reproductive rights and access to reproductive health care. The impact of these changes will be felt first and most acutely by people who have been historically disenfranchised, such as Black, Indigenous, and other people of color; low-income people; and immigrants. To meet these unprecedented times, NIRH will focus on policies that improve access to abortion, expand the availability of contraception, and work toward eliminating racial and economic disparities in health. While each state and municipality has its own set of advantages and challenges, there is need across the country to improve access and remove barriers to care.

NIRH is prioritizing working with state and local advocates to ensure safe, equitable access to abortion without shame or stigma via the following strategies:

- Enshrining affirmative protection for abortion rights and declaring institutional support for abortion as health care;
- Improving access to abortion care by repealing criminal abortion laws and removing barriers for those in state and those traveling, including mandatory delays or waiting periods, medication abortion restrictions, physician-only requirements, and parental involvement mandates;
- Requiring insurance coverage for abortion care without restrictions or broad religious exemptions;
- Seeking funding for abortion care to ensure that financial constraints do not prevent or delay patient access;
- Ensuring the safety of providers, staff, and patients at clinics.



NIRH recognizes that we not only need to remain vigilant against restrictions on contraception access but also work to expand affordable, convenient access to contraception. For 2022, we are prioritizing the following strategies:

- Securing expanded insurance coverage for birth control, including but not limited to 12-month dispensing, over-thecounter methods, and long-acting reversible contraception;
- Ensuring access to family planning and referrals in school-based health centers;
- Training providers in non-coercive, patient-centered counseling.

Finally, NIRH is prioritizing reducing racial and economic disparities in access to reproductive health care by centering the unique needs of birthing people, with a focus on incarcerated people and youth, through the following means:

- Addressing disparities in maternal mortality, including through pregnancy and postpartum insurance coverage expansion;
- Helping pregnant and postpartum incarcerated people access comprehensive reproductive health care, including through protective measures such as shackling bans and accommodations like lactation assistance and nursery programs;
- Mandating comprehensive, age-appropriate, scientifically based, LGBT+-inclusive K-12 sexuality education, including funding for curriculum development and training.
