Mills: Opening Remarks

I wish to welcome each of you to our Second Annual Conference on Legal and Policy Issues in the Americas. We thank many of you for attending this year and last year when the law college began to demonstrate our continuing commitment to collaboration with our Latin American neighbors on issues related to our mutual concerns in policy and in legal issues of education. Since last year, we have expanded our collaborations. The law school is joined this year in sponsorship by the Center for International Business Education and Research, (CIBER), in the Warrington College of Business, and our own *Florida Journal of International Law*, which last year published the proceedings of the conference.
