## AN ACT

For the relief of the Indians of the Fort Berthold Reservation  
in North Dakota.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*  
3        That there is hereby authorized to be appropriated, out of  
4        any money in the Treasury not otherwise appropriated, the  
5        sum of \$400,000 in full and final settlement of all claims  
6        and demands of the Indians of the Fort Berthold Indian  
7        Reservation in North Dakota, composed of the Arickarees,  
8        Gros Ventres, and Mandans, which claims are based upon  
9        stipulations of an unratified treaty dated July 27, 1866  
10        (Kappler's Laws and Treaties, vol. 2, p. 1052) : *Provided,*  
11        That the amount when appropriated shall be deposited in

1 the Treasury of the United States to the credit of the Indians  
2 of the Fort Berthold Reservation and shall draw interest  
3 in accordance with existing laws: *Provided further*, That not  
4 to exceed 5 per centum of the amount herein authorized  
5 may be used by the Secretary of the Interior for payment  
6 of fees and expenses of attorneys employed under contract  
7 approved in accordance with existing law.

Passed the House of Representatives May 20, 1946.
