




Overview of Baseline Needs Assessment

The CORA Surveillance & Epidemiology Core conducted a Baseline Needs Assessment Survey in Vermont to examine mechanisms to improve the delivery of evidenced-based substance use treatment and training for providers in rural VT.

- Deployment Period: April 28, 2020 May 31, 2020
- Method: Electronic Surveys
- Sample:
 - N = 147/689 Practitioners (MD/DO, NP, PA) invited to survey
 - n = 63 Primary Care Physicians




On March 13, 2020 Vermont's Governor declared a state of emergency in response to COVID-19.



Responses by County


63 primary care physicians from rural counties

As part of the assessment providers were asked about their perceptions of changes in substance use and access to treatment services during COVID-19


How has substance use changed?	How has access to Medication for Addiction Treatment changed?
39% "substance use has increased"	2% "access to MAT has increased"
19% "substance use has stayed the same"	34% "access to MAT has stayed the same"
3% "substance use has decreased"	34% "access to MAT has decreased"







There was high level of concern about the use of opioids/opiates

Other Drugs








 Overall, 43% of primary care physicians surveyed were waivered to prescribe Buprenorphine

Concern about opioids/opiates may vary as a function of waiver status

- Decreases in access to treatment
