FOREWORD

The history of women in the accounting profession has been one of long years, but of small numbers. Early records show that a woman, Florence Crowley, was listed as an accountant in the directory of the City of New York in 1797. The first woman to become a certified public accountant was Christine Ross who received New York certificate number 143 in 1899.

The American Woman's Society of Certified Public Accountants was founded in 1933 with nine members and has grown to over 540 members in 1962.

The three primary objectives of this Society are:

1. Encouragement of women accountants in their professional advancement.
2. Improvement of knowledge within the accounting profession concerning the ability and achievements of women certified public accountants.
3. Increase in the number of women who are members and active participants in programs of technical accounting organizations.

In order to encourage more women to enter the profession, in 1938 the American Woman's Society of Certified Public Accountants organized an affiliate, the American Society of Women Accountants, which provides a professional membership for women who may not be certified public accountants but who are engaged in accounting work, who are instructors of accounting, or who otherwise have a substantial interest in accounting. The joint efforts of these two societies have brought a growing recognition and prestige to all women in accounting.

The two societies join in issuing bi-monthly an official publication, *The Woman C.P.A.*, which carries articles on technical accounting subjects written usually by members of the societies.

AMERICAN WOMAN'S SOCIETY OF CERTIFIED PUBLIC ACCOUNTANTS

(Incorporated under the laws of the State of Illinois
on June 21, 1933)

By-Laws

(As Amended October 23, 1959)

ARTICLE I

The name of this organization shall be "American Woman's Society of Certified Public Accountants."

ARTICLE II

The object for which this organization is formed is to advance the professional interest of women certified public accountants.

ARTICLE III

Membership

Section 1. Active membership in this society shall be confined to women who hold valid, unrevoked C.P.A. certificates granted by any state or territory of the United States or the District of Columbia.

Sec. 2. Women certified public accountants who have made outstanding contributions to the Society, or to the profession of accounting, may be elected Honorary Members by a three-fourth majority vote of the membership present at an annual meeting, upon recommendation of the Membership Committee and Board of Directors.

ARTICLE IV

Associates

Section 1. Women who have passed the examination for certified public accountant in any state or territory of the United States or of the District of Columbia, but whose certificates are being withheld until the experience required by law is obtained may become Associates.

(a) Associates shall enjoy all the privileges of the Society, including the right to vote, except they shall not hold elective office or be entitled to describe themselves as Members. They shall be entitled to describe themselves as Associates of the American Woman's Society of Certified Public Accountants.

(b) Upon attaining required experience and certificate, Associates shall automatically become Members.

Sec. 2. Women who hold valid, unrevoked certificates or degrees comparable to the certified public accountant certificate in the United States of America, but who are not citizens of the United States may become International Associates.

(a) International Associates shall enjoy all the privileges of the Society, including the right to vote, except they shall not hold elective office or be entitled to describe themselves as Members. They shall be entitled to describe themselves as International Associates of the American Woman's Society of Certified Public Accountants.

ARTICLE V

Officers and Board of Directors

Section 1. The officers of this Society shall be a President, First and Second Vice-Presidents, Secretary and Treas-

urer. Other regional Vice-Presidents may be elected at the discretion of the Board of Directors.

Sec. 2. The Board of Directors shall consist of ten members, the President, First and Second Vice-Presidents, Secretary, Treasurer, the immediately retired President and four members at large.

Sec. 3. Officers and Directors shall be elected annually either by ballot at the annual meeting or by mail, in accordance with the procedure established from time to time by the Board of Directors.

Sec. 4. Officers and Directors shall be elected annually to serve for a term of one year, or until their successors are elected. No member shall serve more than two successive years in the same office.

Sec. 5. The administrative year of an office shall run from July 1 to June 30.

Sec. 6. A vacancy in the office of President shall be filled by the Vice-Presidents in the order of their seniority. Appointments to other vacancies in the Board of Directors shall be made by the President with the approval of the Board of Directors. Such appointed officers shall serve until the next regular election.

ARTICLE VI

Duties of Officers and Board of Directors

Section 1. Duties of the officers shall be those customary to such office. In the performance of such duties the officers shall be guided by the officers' manual as approved by the Board of Directors.

Sec. 2. The Board of Directors shall conduct the affairs of the Society in accordance with the by-laws, carrying out the policies of the Society as adopted at the annual meeting.

ARTICLE VII

Meetings

Section 1. The annual meeting of this Society shall be held at a time and place decided upon by the Board of Directors. Thirty days' notice shall be sent to the Members, Associates and International Associates.

Sec. 2. Special meetings may be called by the President. The President shall call a meeting within 30 days of a request for such call by a majority of the Board of Directors. Only business mentioned in the call for the meeting may be transacted at a special meeting of the Society.

Sec. 3. Between meetings of the Society, business may be transacted by mail ballot.

Sec. 4. The Board of Directors shall meet at least once each year. Meetings of the Board of Directors shall be called by the President at her own discretion or at the request of a majority of the Board of Directors.

ARTICLE VIII

Nominations and Elections

Section 1. The Nominating Committee shall consist of three members: the immediate Past President, one member appointed by the President, and one member appointed by the Board of Directors. The Nominating Committee shall prepare a slate of officers and directors, which shall be mailed to the Members, Associates and International Associates at least thirty days prior to the date set for the election. Additional nominations, endorsed in writing by

three Members, may be made, provided they are filed with the Chairman of the Nominating Committee not less than fifteen days prior to the date set for the election.

Sec. 2. Officers and Directors shall be elected by ballot at the annual meeting of the Society, or at the discretion of the Board of Directors, may be elected by mail in the manner prescribed from time to time by the Board of Directors.

ARTICLE IX

Committees

Section 1. An Executive Committee consisting of the President, First Vice-President, and two other members of the Board of Directors may be appointed by the President to function in the interim between meetings of the Board of Directors.

Sec. 2. The President shall appoint the following Committees with the consent of the Board of Directors:

Award	Publications
Education	Public Relations
Budget and Finance	Publicity
Legislative	Research
Membership	Yearbook

Policy and Procedure

Special committees may be appointed by the President.

Sec. 3. Duties and responsibilities of standing committees shall be such as prescribed by the Board of Directors of the Society and set out in the officers' manual.

Sec. 4. A budget prepared by the Budget and Finance Committee shall be submitted to the Board of Directors for adoption. No committee or officer may exceed the appropriations set forth in the budget except by special permission of the Board of Directors.

ARTICLE X

American Society of Women Accountants

Section 1. As a means of increasing the interest of women in accounting, this Society shall act in cooperation with the American Society of Women Accountants.

ARTICLE XI

Removal of Members and Associates

Section 1. Any Member, Associate or International Associate guilty of unethical conduct shall be subject to suspension or dismissal from the Society by the Board of Directors in accordance with rules and regulations set out in the manual of procedure.

ARTICLE XII

Quorum

Section 1. At all meetings of the Society 40% of the Members (in person or by proxy) shall constitute a quorum, provided at least twenty Members are present in person, two of whom are members of the Board of Directors. When business is transacted by mail, ballots cast by 40% of the Members shall constitute a quorum.

Sec. 2. A majority of the Board of Directors shall constitute a quorum provided at least two officers be present.

ARTICLE XIII

Dues

Section 1. Annual dues of Members, Associates and International Associates shall be \$10.00 per year. For new Members, Associates or International Associates joining the Society after January 1, the dues shall be \$5.00 for the partial year. Honorary Members of the Society shall pay no dues.

Sec. 2. Dues shall become payable on July 1 of each year, and shall be paid within eight months. Any Member, Associate, or International Associate whose dues have not been remitted within this time may be dropped from the Society.

Sec. 3. The Board of Directors may reinstate a person whose membership shall have terminated for nonpayment of dues upon application for reinstatement accompanied by tender of payment of all arrears in dues to the Society accrued to date of termination plus the current year's dues.

Sec. 4. Dues shall cover the annual subscription, \$1.25, to The Woman C.P.A., official publication of this Society.

ARTICLE XIV

Fiscal Year

Section 1. The fiscal year of the Society shall end on June 30 of each year.

Sec. 2. The accounts of the Treasurer shall be audited at the end of the fiscal year by an auditor appointed by the President.

ARTICLE XV

Parliamentary Authority

Section 1. All points not specifically covered by these by-laws shall be governed by the rules contained in Robert's Rules of Order Revised.

ARTICLE XVI

Amendments

Section 1. The by-laws may be amended at the annual meeting or at any special meeting duly called for this purpose. A two-thirds vote of the Members voting in person or by proxy shall be necessary, notice of such amendment having been sent with the call for the meeting at least thirty days prior to the date thereof.
