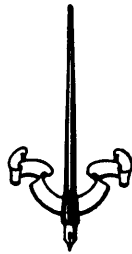

HISTORY

AMERICAN SOCIETY OF WOMEN ACCOUNTANTS

While the keeping of records is as old as civilization, it is only within the last half century that accounting as we know it has become a recognized profession. The first C.P.A. certificate was granted by the State of New York in 1896, and while a woman received the degree only two years later, the profession, until quite recently, has remained virtually a closed one to women.

In 1933, thirty-five years after the first certificate was issued, there were only a few over a hundred women certified public accountants, contrasted with about fifteen thousand men in the profession. It was in that year that nine women certified public accountants met in Chicago and formed the American Woman's Society of Certified Public Accountants, principally because they felt that women certified public accountants would be interested in knowing each other and discussing mutual problems. The organization grew slowly and so did the ranks of women certified public accountants. In 1937, in a population of 130,000,000 people, there were 130 women certified public accountants.

The members of the American Woman's Society of Certified Public Accountants felt that it was not because of a lack of ability but more because of lack of opportunity that women were so poorly represented in the profession, and it was with the hope of increasing the opportunities for women that the American Society of Women Accountants was formed under the sponsorship of AWSCPA.

This Society began with three members in Indianapolis in May of 1938, and in the seventeen years of its existence has grown to 2205 members in forty-three chapters, located in twenty states and the District of Columbia.

It has established a national headquarters at 327 South LaSalle Street, Chicago 4, Illinois. This is also the business office of THE WOMAN C.P.A., the official organ of the two Societies, published bimonthly and going to all members, to the State Boards of Accountancy, to various colleges and libraries, and to many firms of certified public accountants all over the world.

The American Society of Women Accountants was incorporated on July 7, 1953, under the laws of the District of Columbia. On May 6, 1953, the Society was granted exemption from Federal income tax as a business league under the provision of Section 101 (7) of the Code. An information return, Form 990, is required to be filed annually by each chapter with the Director of Internal Revenue in its district, as well as a return for the National Society.

Through the years the Society has held steadily to its purpose--to increase the interest of women in the profession, to increase the opportunities for women, and to inform the public of the place women hold in the field.

Recognized as the Voice of the Woman Accountants, ASWA is a professional society whose ranks are open to women actively engaged in the profession of accounting, to teachers of the subject, and to advanced accounting students.

The ASWA impresses its membership with the privilege and the corresponding responsibilities which are theirs to uphold the high standards of accountancy, to the end that the woman accountant may remain a valued member of an honored profession, worthy of the confidence of the public, and dedicated to its service.

AMERICAN SOCIETY OF WOMEN ACCOUNTANTS
(Incorporated under the laws of the District of Columbia, on July 7, 1953)

NATIONAL BYLAWS *

ARTICLE I

Name

The name of this organization shall be "American Society of Women Accountants."

ARTICLE II

Purpose

The purpose of this Society shall be to advance the interest of women in all fields of accounting.

ARTICLE III

Membership

Section I. Membership in this Society shall be open to women who are interested in some field of accounting. Prospective members must be endorsed by two ASWA members in good standing. There shall be five classes of membership: Regular, Junior, Associate, Honorary, and International Associate.

- (a) Regular: Women, citizens of the United States, who are actively engaged in accounting work and who have had at least two years' accounting experience, may become Regular members.
- (b) Junior: Women, citizens of the United States, who are regularly enrolled students in accounting or who are actively engaged in accounting work, but who have had less than two years' accounting experience, may become Junior members.
 - (1) Junior members shall enjoy all the privileges of the Society, including the right to vote, except that they shall not hold an elective office.
 - (2) Upon attaining required qualifications, Junior members shall automatically become Regular members.

* As amended October 17, 1953

(c) Associate: Women, citizens of the United States, who are not actively engaged in accounting work, or not regularly enrolled students of accounting, but who have a substantial interest in accounting, may become Associate members.

(1) Associate members shall enjoy all the privileges of the Society, including the right to vote, except they shall not hold elective office.

(d) Honorary:

(1) Women, citizens of the United States, who are outstanding in the profession or who have made valuable contributions to the work of this Society, may be elected to Honorary membership. Such a member must receive the approval of two-thirds of the membership.

(2) Women, citizens of the United States, who are outstanding in the profession locally may be elected to Honorary membership by a Chapter. Such a member must be eligible for membership in this Society and automatically becomes a member of this Society under (a) or (c) of this Article.

(e) International Associate: Women, who are not citizens of the United States, may become International Associate members subject to approval of the National Board of Directors. Such a member must be otherwise eligible for membership in this Society under (a), (b), or (c) of this Article.

(1) International Associate members shall enjoy all the privileges of the Society, including the right to vote, except they shall not hold elective office.

(f) The number of Associate and International Associate members in any one Chapter shall not at any time exceed fifteen per centum of the Regular members of that Chapter.

(g) No provision of this section shall operate to change the status of any member who was a member of the organization prior to the date on which these Bylaws were accepted.

Section 2. No woman Certified Public Accountant may become a member of this Society who is not also a member of the American Woman's Society of Certified Public Accountants.

ARTICLE IV

Officers

Section 1. The Officers of this Society shall be President, First Vice-President, Second Vice-President, Secretary and Treasurer.

Section 2. Each Officer shall serve for a term of one administrative year, or until her successor shall have qualified.

Section 3. A vacancy in the office of President shall be filled by the Vice-Presidents in the order of their seniority. Other vacancies on the Board of Directors shall be filled by appointment by the President with the approval of the Board. Such appointed officers shall serve until their successors shall have qualified.

Section 4. Only those who are serving or have served on the Board of Directors of Chapters, and who are members in good standing, shall be eligible for executive office. No person who has not previously served as a member of the Board of Directors of this Society shall serve as President.

Section 5. Duties of the Officers, Directors, and Committee Chairmen shall be such as are specified in the "Officers' Manual" as approved by the Board of Directors.

ARTICLE V

Board of Directors

Section 1. The Board of Directors shall consist of the Officers of this Society and six elective members, three of whom shall be elected each year for a term of two years.

Section 2. The immediate Past President of this Society shall serve as an ex-officio member of the Board of Directors until her successor shall have qualified.

Section 3. Each Director shall serve as Chairman of such standing committee as may be assigned by the President and ratified by the Board.

Section 4. Only regular members in good standing shall be eligible to serve on the Board of Directors.

Section 5. Meetings:

- (a) The regular meeting of the Board of Directors shall be held immediately following the annual meeting of this Society.
- (b) Special meetings may be called at any time by the President or at the request of a majority of the Board. Only such business shall be transacted thereat as that for which the meeting was called.
- (c) Between meetings any business requiring action of the Board may be transacted by mail.
- (d) The presence of a majority of directors in person, or by her own signature where Board meetings are held by mail, shall be necessary to constitute a quorum for the transaction of business at any meeting.

ARTICLE VI

Government

Section 1. The administration of the affairs of this Society shall be vested in the Board of Directors who shall be responsible for carrying out the directives of the Annual Meeting, or as contained in these Bylaws.

Section 2. The Executive Committee shall carry out the instructions of the Board of Directors and conduct the affairs of this Society between meetings of the Board.

Section 3. The fiscal year of this Society shall extend from July 1st to June 30th.

Section 4. The administrative year of this Society shall extend from July 1st to June 30th.

Section 5. The Board of Directors shall provide a manual of procedure, including instructions to Chapters and duties of Committees.

Section 6. The records of the Treasurer shall be audited for each fiscal year, the auditor to be appointed by the President.

Section 7. Government of this Society and all of its legislation and actions shall be conducted in co-operation with the American Woman's Society of Certified Public Accountants with which this Society is affiliated.

ARTICLE VII

Committees

Section 1. The Executive Committee shall be composed of the President, Secretary, and Treasurer.

Section 2. The Advisory Committee shall be composed of the Presidents of all Chapters and the immediate Past President of this Society, who shall be Chairman.

Section 3. Standing Committees shall be Membership, Public Relations, Research, Legislation, Education, Program, Publicity, and Bylaws.

(a) The Chairmen of these Committees shall be appointed by the President and ratified by the Board of Directors.

(b) The members of the committees shall be selected by the respective chairmen, with the assistance of the President.

Section 4. Special Committees may be appointed by the President whenever deemed necessary to the welfare and development of this Society.

Section 5. The President of this Society shall be ex - officio member of all Committees.

ARTICLE VIII

Dues

Section 1. Annual dues of Regular, Associate, and International Associate members shall be \$8.00 per year. For new members joining after February 1, the dues shall be \$5.00 for the partial year. Annual dues for Junior members shall be \$3.00 per year. For new members joining after February 1, dues shall be \$1.50 for the partial year. Honorary members of the National Society shall pay no dues.

Section 2. Dues shall become payable on July 1st of each year, and shall be paid within four months. Any member whose dues have not been remitted within this time shall be dropped from membership.

Section 3. Dues shall cover the annual subscription, \$1.00, to THE WOMAN C.P.A, official publication of this Society.

Section 4. Members of this Society who are also members in good standing of American Woman's Society of Certified Public Accountants shall not be required to pay national dues to this Society. In prorating expenses they shall be considered as members of AWSCPA.

ARTICLE IX

Nominations and Elections

Section 1. The Nominating Committee shall consist of three members, no two of whom shall be from the same Chapter, as follows:

1. The immediate Past President
2. Appointed by the incumbent President
3. Appointed by the Board of Directors

Section 2. The Chairman of this Committee shall be appointed by the President.

Section 3. This Committee shall prepare a list of nominees for Officers and Board members, which list shall be furnished each Chapter President and Secretary before February 1st, to be presented to the Chapter at its regular February meeting or at a special meeting held during that month for that purpose. Additional names may be added to the ballot upon petition signed by at least twenty-five members representing three or more chartered Chapters, provided said petition is filed with the Chairman of the Nominating Committee not later than March 5th.

Section 4. In the event names are added to the list as prepared by the Nominating Committee, voting shall be by secret ballot, conducted by mail in the following manner. Not later than March 25, ballots bearing the names of all qualified candidates shall be mailed to members in good standing whose dues are fully paid for the current year. Such members shall vote by indicating their preference on the ballot and returning said ballot to the Chairman of the Nominating Committee within fifteen days after the postmark date of the ballots.

Section 5. The Secretary, together with one member appointed by the President, shall on the twenty-fifth day after the ballots are mailed to the members, count the ballots that have been returned. A majority of all votes cast shall elect. The results shall be certified to the President. All ballots shall be held and presented to the Board of Directors at the annual meeting, together with a copy of the report as certified to the President.

Section 6. Should no names be added by March 5th to the list of nominees as

submitted by the Nominating Committee to the Chapters, the Chairman of this Committee shall so advise the President. The President shall instruct the Secretary, in writing, to cast the vote of the Society for the slate presented by the Nominating Committee.

ARTICLE X

Meetings

Section 1. The annual meeting of this Society shall be held at a time and place decided upon by the Board of Directors, provided, however, that notice of such meeting shall have been sent to the membership or published in the official publication of the Society at least thirty days prior to the date set for the meeting. The officers shall plan that annual meeting which is held subsequent to the completion of their term of office, subject to the approval of the officers of the current administrative year. The officers of the current administrative year shall conduct the annual meeting.

Section 2. Special meetings may be called at any time by the President, or by a majority of the Board of Directors.

- (a) Notice of such special meeting shall be mailed to the membership at least thirty days prior to such meeting.
- (b) Only such business shall be transacted thereat as that for which such meeting was called.

Section 3. Each Chapter shall be entitled to delegates in person or by proxy to an in-person meeting as follows: One delegate at large; one additional delegate for the first 25 members or less; and one additional delegate for each 25 additional members based on the official membership of the Chapter as of the preceding June 30th. Each Chapter shall have an alternate for each allowable delegate, such alternate to substitute for any delegate who is unable to be present. Quorum shall consist of majority of chartered Chapters represented by delegates or proxies. One delegate may carry all the votes of her Chapter, if her Chapter votes for her to do so. Any Chapter represented by delegates may carry proxies of one other Chapter.

- (a) For regular or special in-person meetings, any regular member in good standing may be named as a delegate.

Section 4. When it is not possible or practical to have an in-person meeting, business may be conducted by mail. Notice of the business to be transacted

shall be sent to the entire voting membership. Each Chapter shall conduct a discussion of the business at the next regular meeting of the Chapter, or at a special meeting called for that purpose at which a quorum is present, and take a roll call vote, reporting the "Yes" and "No" votes to the National President of ASWA within forty-five (45) days from the date the notice was mailed by the National Society to the members. Results of the voting shall be totaled, and a majority vote shall carry, provided a majority of the chartered Chapters have voted.

ARTICLE XI

Chapters

Section 1. Ten or more prospective members, eligible for regular membership, may petition this Society for a Chapter.

Section 2. Such prospective members shall submit their applications for membership in this Society, with copies of the proposed Bylaws for such Chapter in sufficient number for each member of the Bylaws Committee, and a charter fee of \$10.00 plus current individual fees, to the President of this Society.

(a) The National Secretary shall institute a Chapter of the American Society of Women Accountants when the Bylaws have been approved by the Bylaws Committee and the applications for membership have been approved by the Membership Committee.

Section 3. The administrative year and fiscal year of all Chapters shall coincide with that of the National, July 1st to June 30th of the following year.

Section 4. Chapters shall hold at least ten regular monthly meetings during the year.

Section 5. All members of this Society shall have guest privileges in any Chapter, which privileges, however, may be limited at the discretion of such Chapter to three meetings.

Section 6. Members may apply for transfer of membership from one Chapter to another by application on the proper form.

ARTICLE XII

Charges

Section 1. The Board of Directors shall have power to suspend or expel any member guilty of unbecoming conduct.

Section 2. Charges may be brought by any member having knowledge of such acts but must be in writing and accompanied by due proof.

Section 3. The accused shall receive a copy of such charges and be given an opportunity to defend herself.

ARTICLE XIII

Parliamentary Authority

All points not specifically covered by these Bylaws shall be governed by the rules contained in Robert's Rules of Order Revised.

ARTICLE XIV

Amendments

Section 1. These Bylaws may be amended at any annual meeting, or any special meeting duly called, either in person or by mail. Two-thirds (2/3) affirmative vote of Chapters represented by delegates or proxies shall be necessary in an in-person meeting, or two-thirds (2/3) of the votes cast if voting is by mail, provided a majority of chartered Chapters have voted.

Section 2. A notice of such amendment must be sent with the notice of such annual or special meeting at least thirty (30) days prior to the date of the annual or special meeting.
