





- Improved quality of life, public services, schools, safety, mobility of people and to achieve environment sustanability






The Digital Economy



Internet Broadband Usage








Fixed Broadband Subscription


50% subscription of fixed broadband service per 100 households and businesses in Brunei Darussalam. (as of 2019, source: AITI)
