BACKGROUND/PROBLEM

- The Florida Department of Health (FDOH) audits administration rate of Hepatitis B Vaccine (HBV) in newborns prior to discharge from the hospital
- South Miami Hospital (SMH) rate for Hepatitis B vaccine was at 60% in Jan 2021; Healthy People 2020/2030 benchmark is 85%
- Many of our pro-vaccine patients parents are choosing to defer the HBV administration, likely due to knowledge deficit.





GOAL(S)

- Short-term goal: Increase administration of Hepatitis B vaccine to newborns prior to discharge at 70% prior to discharge
- 2. Long-term goal: Achieve the FDOH benchmark of 85%

PLAN

- Assess nurses' level of knowledge regarding: pre-discharge Hepatitis B vaccine to newborns
- Educate all the mother and baby unit staff members on recommendations from Advisory Committee on Immunization Practices (APIC) / Center for Disease Control (CDC) and the FDOH
- Collaborate with Pediatrician team to help educate patients
- Conduct a literature review for benchmarks to establish goals
- Communicate benchmark data and vaccine administration goal to staff

INTERVENTIONS


Pre-Intervention:

- February 2021: Conducted a literature review on Hepatitis B vaccine administration benchmarks and established goals
 - o Journal article research performed by Sai Paulvkin, RN and Lisa Barroso, RN on "Hepatitis B Vaccine Administration"
- May 2021: Pre-survey given to staff to access knowledge on Hepatitis B vaccine administration

Intervention:

- August 2021: Provided education by in-service to Mother-Baby Staff and Pediatrician Team on increasing Hepatitis B vaccine administration before discharge:
 - Reinforced ACIP / CDC recommendations
 - Responding to parents: "We recommend giving the Hepatitis B vaccine prior to discharge
 - o Staying away from saying: "It's up to you if you want to give it in the hospital or with your pediatrician's office."
