Analysis and Assessment:

- Unlike many other genres, the goal of a literature review is *not* to argue for interpretation of based on research
- Instead, literature reviews assess the current state of research, noting trends, unanswered questions, or gaps
- Often, this assessment is your basis for further research action



Establish your intended purpose:

- To establish need: identifying shortcomings or gaps in existing research, and therefore the need for new research
- To establish ethos: the author communicates their awareness of critical or foundational literature in their area of study

LR Structure: Introduction

I. Introduction

- a. Describe the overall topic that you are investigating, why it is critical in your field, and your situational interest in the topic
- Describe the current situation of the topic in the field's discussion. Broadly state trends in research, methodology, and findings, but don't zoom in on small details yet; establish an overall view of the literature

Why is it important?

What is the critical question or need that drives this research?

LR Structure: Major Themes

II. Major Theme A

a. Introduce the overall theme; establish commonalities or critical issues that all subthemes below fit within Describe the general concept that unites a limited group of your findings.

LR Structure: Sub-themes

- b. Sub-theme narrow collection of similar/related findings fitting within the major theme
 - i. Source 1 Analysis
 - ii. Source 2 Analysis
 - iii. Source 3 Analysis

Expand; why is <u>this</u> part important to the Major Theme, and therefore the whole? Source <u>analysis</u> is the core information that drives a literature review.

Don't just report - *connect*.

For each source analysis:

 Summarize the source's research question, the methods used, and critical findings or conclusions

AND

 Make connections between sources in each sub-theme; build meaning; show you are reading the field, not just one source

LR Structure: A Repeating Process

- C. Sub-theme a *different* narrow collection of similar/related findings, still fitting within the earlier major theme
 - i. Source 4 Analysis
 - ii. Source 5 Analysis
 - iii. Source 6 Analysis
- d. ... and e. ... and f. repeat this structure as necessary with subsequent subthemes, still fitting within major theme
- III. ... and IV... repeat all steps from above, but now with a new, separate major theme

See how the structure repeats? The approach is the same, but the focus differs as we proceed.

Literature reviews expose the web-like connections between research.

Connect the strands.

Referring to sources covered earlier is usually a a good thing in literature reviews:

- There's no need to reintroduce and resummarize; just highlight newly relevant details
- It may be helpful to your audience to note you are directing their attention backward momentarily

LR Structure: Conclusion

- V. Conclusion*: An evaluation/critique of the existing literature; this is longer than an essay conclusion
 - a. What are the contributions of this literature to the field?
 - **b**. What are the overall strengths?
 - c. What are the overall weaknesses?
 - d. What might be missing?
 - e. What are some next steps for research? The next steps should explicitly address how to "correct" for strengths, weaknesses, and gaps


These details may appear earlier, depending on the field.

Everything above leads to and supports these points
