To the best of our knowledge, there has never before been compiled a directory of churches of Christ in the 12 Northeastern states in this country. There have been some individual directories in the various states, but this is the first complete directory of churches.

North Atlantic Christian magazine has for its purpose the task of informing, teaching, and promoting the fellowship and growth of the church. Feeling that one way it could promote the fellowship of the churches in this area, this work was undertaken. We hope it will serve as a ready guide to congregations and preachers in this section.

Much information is lacking on some congregations so these statistics are not completely accurate, but they are probably the best that can be secured at this time. The statistics would naturally be low on the size of the churches because of the growth which takes place continually. Also, the membership sizes of several congregations was not available, so the statistics will necessarily be lower than the actual situation in each church.

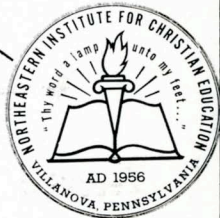
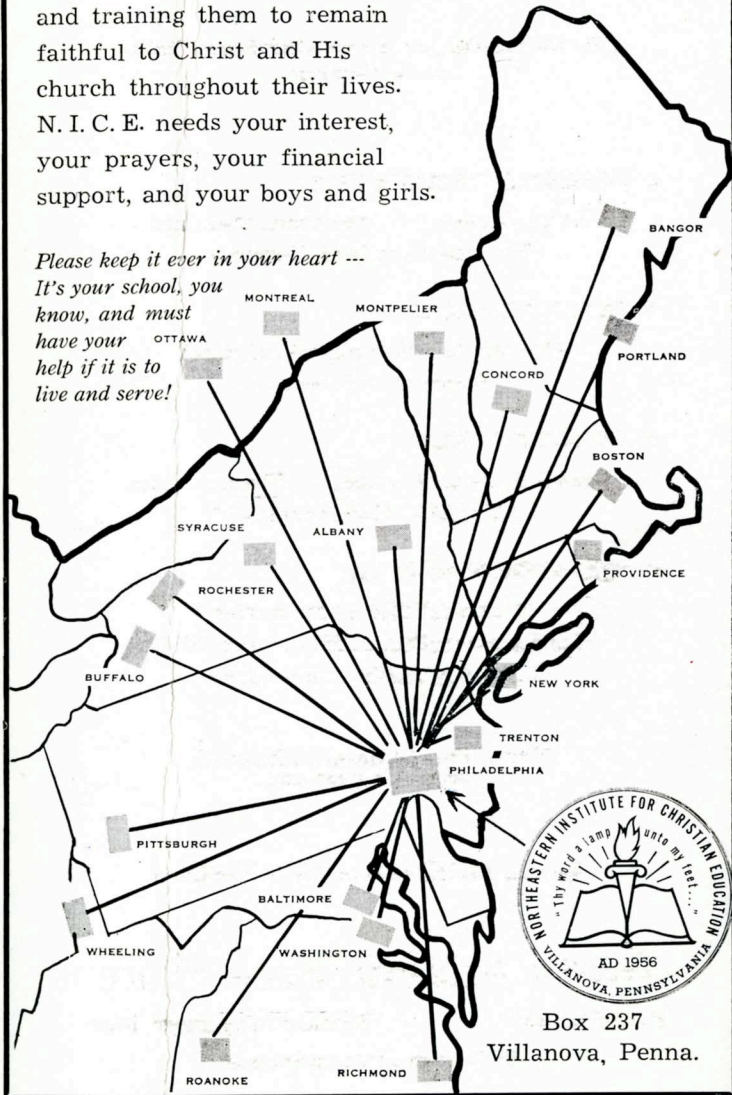
