

BIBLIOGRAPHY AMERICANA GERMANICA 1978*

WITH this issue a new feature is added to the *Journal of German American Studies*. The "Bibliography Americana Germanica" was instituted in 1942, first under the auspices of the Modern Language Association and subsequently of the Carl Schurz Memorial Foundation and its well-known publication, *The American-German Review*, to be continued from 1968 to 1971 in the *German Quarterly*, organ of the American Association of Teachers of German. It is the intent of the Society for German-American Studies not only to resume the printing of this annual list, but also to close the gap of six years—1972 through 1977—during which it was in abeyance.

Through the efforts of a committee of dedicated volunteers drawn from the Society's membership it has been possible to prepare the bibliography for calendar 1978 in a format and on a scale comparable to that maintained in the earlier publications. The principal series and journals issued in this country and abroad whose subject matter touches on migration, ethnic history, comparative literature, local history, art, folklore, linguistics, etc., have been screened and extracted for matter pertinent to our subject. The list for 1978 is an annotated, indexed bibliography of books, articles, dissertations (and incidentally of manuscripts, films and microforms, exhibits, conferences, symposia) together with references to the reviews thereof, bearing on the life and culture of the German element in the United States and Canada from Colonial times to the present. While we take as a guiding principle that it is wise to be broadly inclusive in our selections, yet certain technical and specialized materials

have been omitted: works on the pedagogy and school instruction in the German language; the textbooks used in such teaching; also works of diplomatic history, international relations, and post-war economic and political relations with the Germanys.
