Suggested Amendments to the Constitution and By-Laws of "The National Society of Certified Public Accountants in the United States."

ART. II, SEC. 2. Omit the first word "all." Same Sec. Omit the words "Regents of any University, Court of Record or Board of Examiners named," and insert the words "those duly" in their place.

I vote aye in favor of the above.

ART. III, SEC. 2 and SEC. 3. In place of present section read Sec. 2. "The Society shall be governed by a Board of twenty-five directors chosen from the senior members of the Society, who shall be known as the Board of Governors, and who shall serve as such for the term of one year, or until their successors are elected."

I vote nay against the above.

SEC. III. These directors shall be divided among the States that have legalized Certified Public Accountants in proportion to the number of Certified Public Accountants in each State on the first day of December in each year. In those States where an incorporated society of Certified Public Accountants exists that affiliates with the National Society, it shall have the power to name the directors apportioned to their State, but where no such organization exists, the members of the National Society belonging to the State shall select their representatives upon the Board. Certified Public Accountants holding certificates from more than one State shall be entitled to but one vote and must elect from which State they desire representation.

I vote nay against the above.

Omit Art. III, Sec. 4.

I vote nay against the above.

Insert an additional section in Art. III called Section 5. "If, owing to any cause, a vacancy arises in the Board of Directors, or in any of the offices enumerated in Section 2 of this Article, the remaining Directors shall have power to fill the vacancy for the unexpired term."

I vote aye in favor of the above.

ART. XII, SEC I. After the words "may then be debated," omit the remainder of the sentence and insert the words "and amended, and shall then be voted upon."

I vote aye in favor of the above.

ART. V. Add additional section to be named Sec. 8, to read as follows: "EXECUTIVE COMMITTEE. The President, Secretary, Treasurer, and four members of the Board of Governers, to be selected by the President, shall constitute an Executive Committee, which Committee shall be vested with the full powers of the Board of Governors to act between meetings of the Board, but whose acts shall only remain in force till the next regular meeting of the Board, when they shall be ratified or rejected."

I vote aye in favor of the above.

Omit in Art. VIII, Sec. 1, of By-Laws the words following: "by proxy," and insert in their place, "by any member." I vote aye in favor of the above.

I hereby authorize the Secretary, as my attorney, to vote in my stead and place, as though I was personally present at the annual meeting of The National Society of Certified Public Accountants in the United States, convened to be held on Tuesday, December 27, 1898, and I hereby endorse and ratify the selection of the gentlemen named for the several offices, also to vote as directed for the foregoing proposed amendments to the Constitution.
