

Letter to the Editor: Proposition 227 - The Unz Initiative

#### **Proposition 227 The Unz Initiative**

We all have a very important decision to make as we vote in the primary election on June 2, a decision that affects not only the lives of thousands of our children, but also the long term viability of our workforce and, perhaps, of our democratic society itself. The Unz initiative to eliminate bilingual education in our schools is tragically shortsighted, mean spirited, and divisive. Let me explain why.

As humans, language is our most important, most distinctive tool. It enables us to communicate with one another at a level and a complexity unknown in other species. It is the source of our civilization, our ability to pass culture and history from genera-



tion to generation. Language allows to communicate with Thomas us Jefferson, read Paul's letters to the Romans, or enjoy the works of Pablo Neruda or Sor Juana Inez de la Cruz. Language transcends the boundaries of time and space-and because of it we can communicate with one another around the world and through time. The Internet is impressive, but language itself is the real "world wide web." Language, the tool that allows us to share these thoughts now, is what the Unz amendment proposes to put at risk. How? By interrupting the normal, complex, wonderful development of linguistic ability to artificially force the learning of English in a way that will compromise the intellectual development of our children.

Worldwide research suggests that there is a steady process of mental development through childhood. Its depth and power depend largely on the development of neural linkages through language. It is more important to first develop strong, powerful minds in whatever language. Then a second language can effectively be added. Lose the developmental, neural foundation and any language, including English, will be compromised,

Proposition 227 would not only stifle the intellectual development of our children, it would also stifle their later ability to learn other languages. Think of the irony: we intervene to stamp out a native language at a critical time in the intellectual development of youngsters, and then tell them they should learn a foreign language five years later-when we have succeeded in making it truly foreign.

One of the greatest sources of the



excitement and promise of San Diego comes from its international character. Here we are on the threshold of Latin America and the rim of the Pacific. Can there be any doubt that our economic and social futures lie in being multicultural? And yet Proposition 227 would rob us of that, by driving a wedge between us and our future. Just as Propositions 187 and 209 drove business and trade (i.e., dollars and jobs) away from California to Texas and Arizona, so too would Unz send a signal of isolation and cultural insensitivity that will hurt our state, and our commerce with the global community.

Everyday I see firsthand the wonderful results of natural linguistic development on our campus. Many of our students are not native English speakers. It is a delight to walk across campus and hear Spanish, Chinese, Tagalog, as well as English and other languages being spoken. That tells me that our students have the intellectual foundation necessary to succeed and to make a greater contribution to our society-which is why they came to San Diego State in the first place. Through their bilingualism, we will be better able to speak with and interact with the world.

It concerns me that we would ever say "'sink or swim" to any child on an issue as fundamental as intellectual or linguistic development. That is not worthy of us or of the society we have built. But I am particularly concerned when we forget that our society, our economy, and our future will sink or swim with these very same children. I have previously studied Latin, German, and French. Since coming to San Diego I have devoted about 30 minutes a day (now for two years) to learn Spanish. The results (as anyone who has heard me speak in Spanish will attest) are pitiful. I do not doubt that our youngsters will be better students of

marks by returning to my earlier comments about the centrality of communication in the development of human beings. The word "communication" comes from a Latin word meaning to share, It has the same root from which our word "community" is derived. We are a community precisely because we can share (communicate) with one another. That does not mean that we all speak the same language, but that we share the human gift of language itself. Proposition 227 would compromise the intellectual and linguistic development of our children. It would diminish their ability to share in the global community of thought, and it would consequently make California a less effective voice on the world stage.

For these reasons I will vote no on Proposition 227; 1 urge my fellow Californians to do the same. A no vote is a vote for our children's future ... and our own.

#### **Bilingual Educators Say** "NO" to Prop 227

Los Angeles, CA - The governor of California has once again failed the children of the state by deciding to support the highly-flawed, "English-only" initiative known as Prop. 227, according to Silvina Rubinstein, executive director of the California Association for Bilingual Education. Gov. Wilson's veto message regarding SB6, a bill that would have dramatically altered bilingual education in the state, also demonstrated his complete lack of commitment to providing quality education to all of California's children, said Rubinstein.

"The governor has failed every single child, not just those in bilingual education classes, with his decision on Prop. 227 and his SB6 veto message," said Rubinstein. "His statements regarding SB6 and Prop. 227 clearly show his lack of leadership in assuring that our children are properly prepared for the future.'





### San Bernardino City Schools Exemplary Employees Honored

Outstanding service to students is what earned ten San Bernardino City Unified School District employees the coveted Board of Education Exemplary Employee Award.

The honorees included Gustavo Chavando, a Bilingual Resource Teacher at Monterey Elementary School; Matthew Maeda, a Teacher at San Gorgonio High School; Debbie Castellanos, a Community Resource Aide at Wilson Elementary School.


Chavando created a bilingual resource room at his school to generate materials to help teachers get the most from their students. He initiated PRICE, a literacy program which focuses on English Language development and good patenting skills. Coworkers say he stimulates children's' natural desire to learn, leading to academic improvement, regardless of race, religion,

economic or social background or the past leadership team and has led his soccer teams academic history. He treats them all students equally, giving them the tools to be successful students and successful members of society.

Matthew Maeda graduated from San Gorgonio where he now teaches math/science and coaches girls soccer. He was the valedictorian of his 1995 graduating class. Maeda stresses the importance of education, hard work and responsibility to his students and players. He created a SAT (Scholastic Aptitude Test) prep class for them and comes in early to teach the class. The benefit to his advanced placement students is dramatic: their passing rate increased from 22 to 58 per cent. He often helps students to research colleges, grants and scholarships so they can continue their educations. Maeda is the ASB (Associated Student Body) advisor, serves on the school

to six straight league titles.

Debbie Castellanos' nickname is "the terminator" because of her doggedness in ferreting out truants. With Castellanos on the case, most students are back in school the next day. After a visit from Debbie, one parent promised her child would be in school every day "just please don't send Debbie back". Although determined to keep students in school, Castellanos doesn't club parents over the head, her first question to them is "what can I do to help you". She schedules visits to the school nurse or health aide when students need medical attention; she coordinates visits to the school counselor when parents need help with personal matters or have parenting questions; she finds food, clothing and even shelter when needed.



#### TO WHOM IT MAY CONCERN:

The District Bilingual Advisory Committee wishes to express their intentsic oppose Proposition 227, the "English for the Children" Initiative. The District Bilingual Advisory Committee agrees with the position taken by the District School Board and evidenced by the reading of February 17, 1998 of the Resolution Resarding the English Language Education for Immigrant Children Initiative.

To oppose Proposition 227, the "English for the Children" Initiative, is congruent with school sentiment of the bilingual community in San Bernardino. Given the fact that English Language Learners need more than English and that Proposition 227, the "English for the Children" Initiative, will prescribe English language development Instruction for one year at the cost of learning academic subjects such as math, science and history, the District Bilingual Advisory Committee urges everyone to vote no on Proposition 227, the "English for the Children" Initiative.


Furthermore, the District Bilingual Advisory Committee feels that English Language Learners need to achieve the three program goals:

- To develop fluency in English in each student as effectively and efficiently as possible
- (2) To provide equal opportunity for academic achievement, including, when necessary, academic instruction through the primary language
- (3) To promote students' positive self-image; promote crosscultural understanding

It is, therefore, necessary that District bilingual programs are continued and that, rather than eliminate them, they receive more support so they can become exemplary and all students can achieve the three programmatic goals and contribute to the democratic citizenry of their future.

Houston, Texas - Latino elected and appointed officials from all over the United States will assemble for the National Association of Latino Elected and Appointed Officials' (NALEO) 15th Annual Conference to be held at the Doubletree Hotel at Post Oak in Houston, Texas from June 18 - 20, 1998. With this year's theme, "Launching a Plan for the Future," participants will explore strategies to improve the education of Latino children and examine the current state of affirmative action to ensure access and equity.

"The conference will explore indepth the two most important issues to Latino elected and appointed officials today: education and affirmative action," said Arturo Vargas, NALEO Executive Director.

The Conference once again convenes the largest gathering of Latino public servants, as both newly elected and veteran officials converge to learn, network, and deal with the critical issues facing Latinos across the nation.
