# This is Not a Matter of Personalities

Susan Bialek is now the Student Senate President; Cathy O'Connor joins the elite of leaders removed from office. On Monday Sept. 29, the Student Senate voted to remove O'Connor from the office of president on the charge of violating Article II, Section I of the Student Constitution.

O'Connor was not present when the votes were tallied. She had walked out fifteen minutes earlier because the Senate had not granted her a one week continuance. O'Connor wanted another week to prepare her case - she was given specifics on seven charges and dates of the violations five days before the trial, while three still remain unspecified. Another reason for her asking a continuance was that certain ground rules were laid out at the meeting, such as what role the attorneys would play, and whether witness' would be called had not been determined prior to the trial. O'Connor plans on appealing, and should she win the appeal, the Senate would have to retry her.

The charge that convicted O'Connor is the article of the Student Constitution that defines quorum. It is not a statement of the necessity of quorum to hold legal meetings. The article reads: The legislative body of the Student Community (Graduate and Undergraduate) shall be known as the 'Student Senate'. It shall discuss and pass legislation pertinent to the Student Community. A quorum shall consist of 50 per cent plus one of the voting members of the Student Senate."

The office of the President now belongs to Susan Bialek, she is the third president since the

last election. Back in March, Dean Alexandrou was elected President by the students, O'Connor was elected Vice President, Malika Willouahby Secretary and Sharon Bialek Treasurer. Alexandrou resigned his position on the first day of his office; O'Connor moved up to president and nominated Sue Bialek for Vice-President.

The impeachment was not the first order of business for Senate. Sen. Drakhart proposed that "all media and equipment leave the room." The meeting was being broadcast live by WZRD and was being video taped. The Senate thought media expulsion was a favorable idea, then took a short recess where they met in closed session. When they returned, they allowed restricted media, no one was allowed past the first row of spectator chairs. The Senate also decided that "no questions or statements would be entertained from the audience."

As an aide to explain to those who didn't have the first hand account of the proceedings, it was obvious that O'Connor was stonewalled when any matter of importance arose, both in weeks gone by and at the proceedings of the 29th. The Student Government represents students in matters of student welfare. An interested concerned legislative body would see that one week could not make that much difference to the "student body", while it would really bring the impeachment question to an end. The business would be resolved correctly and there would be no reason for O'Connor to bring in the Supreme Court. Instead the ugly cloud still remains over the entire mess.

## Commentary

Despite what the accompanying editorial states, the Student Senate meeting of last Monday night proves that Student Senate does work. It works to the advantage of certain individuals in it. However it does not work, I am sure, in the manner in which it was designed to.

Specifically, the Senate does not appear to know its own rules. Article II section IV of the Student Constitution, drawn up by the Senate, states that "All Student Senate meetings shall be open and publicized to all members of the University community." The Senate, in what we wish we could call a rare display, banished the student media during the first minutes of the meeting. The uproar over this was so tremendous that they had to recess for a few minutes to hold a private meeting during which, it may be supposed, they took the opportunity to read their own constitution. Upon their return they grudgingly agreed to allow the media to remain provided they stand so far back as to preclude any possibility of hearing Senator Hengels speak.

With this restriction carried out the Senate proceeded to make up their own rules regarding impeachment. Space does not allow us to list every rule thought up at the meeting, suffice it to list just one example. The Senate voted to allow Cathy O'Connor to present witnesses in her behalf providing that O'Connor present them with a list of witnesses prior to the hearing. Sounds fair, except that the meeting Monday night was the hearing, presenting the problem of how to present a list to the Senate when they have notified you that they wanted the list yesterday and today (the day they made up the ruling) is too late.

The result of all this as you may have guessed was that O'Connor was impeached. She was removed from office on a violation of Article II section I of the Constitution which reads; The legislative body of the Student Community (Graduate and Undergraduate) shall be known as the "Student Senate". It shall discuss and pass legislation pertinent to the student community. A quorum shall consist of 50 per cent plus one of the voting members of the Student Senate."

Obviously this article is merely a definition of the Senate and of what quorum shall consist of. It most certainly is not a statement that quorum is a necessary or desirable thing, or that Student Senate is, in like manner, a necessary or desirable thing.

The meeting Monday night raises some serious questions regarding the ability of the Senate to carry out the wishes of the Student body which elected them. It is our view that the Student Senate is not an able body to represent the Student Community.

OOPS! The Print does on occasion make mistakes. Last issue we reported that Senator Steven Gold had been absent at two senate meetings during the summer. Mr. Gold was indeed present at the meetings in question. We would also like to take this opportunity to thank Senator Gold for his support of student media rights. In his unswerving devotion to the students Mr. Gold has become the conscience of the Senate.

## Editorial

All the uproar and confusion which has characterized the Student Senate in the past few months leads to one conclusion: The present Student Government does not work.

Student Senators have commented publicly that it is difficult to find an officer in the senate office when one is needed. Other Student Representatives are virtually running every committee in Student Government. (Despite their protests to the contrary).

Senators who are unfamiliar with the student constitution listen to others who misinterpret the constitution. Other Senators, unable to find the information they desire in the constitution refer to outside sources and quote those sources as if they were written in the student constitution.

Still other Senators, (the majority) are unable to make the meetings on a regular basis, most don't even bother to stop at the senate office from time to time to find out what's going on and have to rely on phone calls from fellow Senators who are lobbying for or against an issue, for information.

The student constitution itself is past due for major revision. One section (since deleted) provided for a Student Activities Council, part of who's function was to appoint members to both the Charter Review Board and the Student Fees and Allocations committee. Because its members were supposed to consist of one voting representative from each board of control, the Student Activities Council served as the voice of the student clubs. If there is to be no Student Activity Council, then its functions should be carried on by some other body which would represent, in the same manner, those clubs and organizations that the Student Activities Council once did.

The current impeachment furor has many people wondering why there are no specific guidelines for impeachment proceedings. Presently, it appears to be up to the Senate to interpret and apply what few, ambiguous guidelines there are.

Because of all these reasons, the Student Senate should, as a whole, resign their positions and a general election should be held to select a new Senate. The new Senate should immediately revise or rewrite the student constitution to provide for:

- (A) Stricter guidelines for the appearance of Student Senators at Senate meetings.
- (B) Legislation whereby no member of student government could serve on more than two student government bodies.
- (C) Re-establishment of representation for the various student clubs/organizations.
- (D) Specific guidelines for removal of student government representatives or officers.

Without the changes presented here, the student government will continue as a non-functional, semi-representative body, constantly fighting itself and improperly and contemptuously misusing the authority which it has been given.



This is a copy of the notice of appeal filed by Cathy O'Connor.

NOTICE OF APPEAL

Please take notice that an appeal to the Student Supreme Court, (or if that Court as now constituted, is unable to so hear said appeal, then to the President of Northeastern Illinois University) from a decision made at the Student Senate Meeting of September 29, 1980 is hereby being made in behalf of President Catherine A. O'Connor.

Issues for Appeal:

I Whether the Senate Violated basic due process in failing to provide Ms. O'Connor with specific allegations regarding certain impeachment charges being brought against her by the Senate.

II Whether the Senate abused its power under the Student Constitution by failing to grant Ms. O'Connor a continuance as she requested prior to the aforesaid meeting and again at said meeting when

A) The procedures whereby the trial was to be held were only finalized at said meeting thereby rendering the preparation of a defense impossible .

B) That among the aforementioned procedures, there was included a determination of a right to counsel. Therefore, prior to the date of the meeting, counsel could not assist in the defense of Ms. O'Connor.

C) That among said procedures, there was a requirement that Ms. O'Connor produce a list of witnesses to the Senate prior to trial, a requirement which could not have been complied with, given the lack of specificity of the charges presented.

III Whether the right to counsel can be limited to the point whereby said counsel can be prevented from participating in the trial itself, but limited to a mere advisory role.

IV Whether the Student Senate can usurp the role and authority of the judicial branch of Student Government by interpreting the Student Constitution and declaring certain types of meetings to have been illegal when in fact the provision of the Constitution relied upon by said Senate has not been interpreted by the Student Supreme Court.

The petitioner respectfully asks that the Student Supreme Court, if properly constituted with a constitutionally sufficient number of disinterested members, or in the alternative, the President of Northeastern Illinois University set these matters for a hearing on a date certain, that it reverse the proceedings undertaken at the Student Senate Meeting of September 29, 1980 and that it set the trial for a time to be not less than one week after the Senate complies with the requests made by the Defendant, Ms. O'Connor, regarding specificity of certain charges.

*Article XIII of the STUDENT Bill of Rights*

The right to publish and distribute news, opinions, and literature shall not be infringed. The student media should be free of censorship and advance approval of copy, and its editors and managers of student media should be protected from arbitrary suspension and removal because of student, faculty, administrative, or public disapproval of editorial policy or content. Only for proper and stated causes should editors and managers be subject to removal and then by orderly and prescribed procedures. The agency responsible for the appointment of editors and managers shall be the agency responsible for their removal. All university published or produced and financed student media shall explicitly state in on the production or printed material that the opinions there expressed are not necessarily those of the college, university, or the student body.

It was a good time. We look forward to next year.


## Counseling Center Offers Workshop

## Notice for Students on Academic Probation

Students on academic probation - please note - Recently you received a letter from the Director of Admissions and Records advising you that you are now on

academic probation. Soon you will be receiving an invitation from the University Counseling Center, B-115, urging you to take advantage of the services offered by a staff of counselors ready to help you to return your record to good standing.

Since your cumulative grade point average has fallen below the required 3.0 (C), you should not delay arranging a session with a counselor who will review UNI's scholastic regulations concerning probation, as well as help you understand various factors which may be contributing to your poor performance. You will be assisted in making plans to overcome these difficulties. This may include help in making more efficient use of study times, overcoming anxiety in regard to taking examinations, etc. Personal concerns may also be discussed.

"If you do not receive any correspondence as mentioned above, but feel that you need help with your studies to avoid being dropped for poor scholarship, please don't hesitate to stop by to set up an appointment," Ms. McCreery, Coordinator of Academic Advisement, urged. "We are anxious not to overlook anyone who would like assistance, and are particularly interested in reaching students on probation who may have been off campus for a trimester or two and therefore, were not on our mailing list this fall."

Counselors can assist students on probation who have not yet decided upon a major in planning their course programs for the winter trimester. This is especially important since it will soon be time for advance registration. Students should also remember that their advance registration will be cancelled if they do not make the required progress in returning their records to good standing by the end of this trimester.
