This is an ethnology seminar for anthropology graduate students; consent of instructor is required for non-degree graduate and undergraduate students to participate. Readings are on reserve at the Mansfield Library, and required selections from each book have been scanned electronically to a Moodle supplement. After the first meeting, students are expected to come to class prepared to discuss the readings with a set of questions, or brief commentary prepared in advance. Discussion leaders for each topic will read the entire ethnography, as well as supplemental readings to establish context.

## **Grading Policy:**

Students will be evaluated on consistent attendance, participation in discussion, and an oral presentation of a research paper on a topic chosen in consultation with the instructor. Presentations will be 10-15 minutes each, (10-12 double spaced pages) in the format of AAA meetings, with a title, abstract, and 10 minutes for questions and discussion. The research papers must draw on at least 10-15 sources, and be at least 20 pages in length.
