8 Whereas, The Associated Students of the University of Montana (“ASUM”) is bound by its
9 Fiscal Policy;

10
11 Whereas, Section 9.4.2 of Fiscal Policy currently reads:

13 *The oversight boards for all ASUM agencies, even those with designated funds*
14 *aside from the Activity Fee, shall be responsible for approving a budget prepared*
15 *by the directors of the agencies.;*

16
17 Whereas, On September 8, 2021, the Senate passed SB06-21/22: Resolution Striking Eight
18 ASUM Committees from the Bylaws and Repurposing the Sustainability Board, which struck the
19 oversight board funding process for ASUM agencies;

20
21 Whereas, Section 9.14.2 of Fiscal Policy currently reads:

23 *Every Senator shall serve on at least one Category Allocation Board unless*
24 *exempted by the Vice President.;*

25
26 Whereas, The Business Manager chairs and oversees the budgeting process;

27
28 Whereas, The Vice President chairs and oversees the Senate;

29
30 Therefore, Let It Be Resolved, That Section 9.4.2 be struck from Fiscal Policy;

32 Therefore, Let It Be Further Resolved, That Section 9.14.2 of Fiscal Policy be amended to read:



34 ***The Business Manager, in consultation with the Vice President, shall assign***
35 ***Senators to Category Allocation Boards. Every Senator shall serve on at least***
36 ***one Category Allocation Board unless exempted by the Business Manager.;***

39 Secretary; Gwen Coon, ASUM Office Manager.


