<ul style="list-style-type: none"> • U of Minho Documentation Services (SDUM) • Workflow <ul style="list-style-type: none"> – Initially archive on researchers behalf – Now mainly self-archiving • Approval and Verification <ul style="list-style-type: none"> – Vary between communities • Who pays: <ul style="list-style-type: none"> – E-UM - Virtual Campus Project 	<ul style="list-style-type: none"> • Coordinated by the central library's technical services • Each campus library has regional coordinator • Departments employ students to assist with metadata entry and uploading • Who pays: <ul style="list-style-type: none"> – Primary the library's special project

<ul style="list-style-type: none"> • Submitters grant the university the right to archive on their behalf • University doesn't claim any right to deposited items • Encourage faculty to use Creative Commons licenses 	<ul style="list-style-type: none"> • Submitters grant the university the right to archive on their behalf • University doesn't claim any right to deposited items • Creative Commons is a build-in option during submission
