## Message From The Chair

This past year has been financially tough, but it has also been a year of accomplishment for Illinois State University. We have remained dedicated to Educating Illinois and have continued to advance our reputation nationally. We continue to attract outstanding students. The Comprehensive Campaign finished way above goal and over $\$ 5$ million was contributed by the University family. The campus sailed through the NCA Accreditation visit with flying colors. I attribute this impressive success to the high caliber of people here - administration, faculty, staff and students.

I feel a special pride in the staff of this university because we are the ones who have taken the brunt of the shortages. We are all doing more and doing it with less. I know how hard it has been for many of us. But we did it, and I think we should all feel a great deal of pride in our accomplishments.

When I think back to the origins of the staff Councils, I am truly amazed by how far we have come. The Non-Academic Staff Council of ISNU was formed under President Bone 46 years ago in April 1959. The first Service Awards were given to employees in April 1965. The first Civil Service scholarship award was given in 1969. In 2004, we awarded seven scholarships to dependents of Civil Service employees and one Carl Johansen scholarship. This scholarship is awarded to a Civil Service employee who is seriously working on a degree.

The progress we have made in the past few years has also been remarkable in other ways. Shared governance that included all four governance bodies was formally adopted in 2001. I, as the Chair of the Council, have regular meetings with the President at which we discuss issues freely. The Council now has a campus address and a few hours a week of secretarial help. There are plans for the Council to have an office on the fourth floor of Hovey when space becomes available.

During the past year, the Council has participated fully in the shared governance process. Our members served on many committees, including the Academic Senate, the Planning and Finance Committee, the NCA Accreditation Team, the Advisory Council for the Family Campaign, the Executive Committee for the Committee for Diversity, the Sick Leave Bank Appeals Committee, the Foundation Board, the Campus Communication Committee, the Parking Committee, and many others. Shared governance on our campus is much more than a catch-phrase - it is working very well!

In 2004, the Council was very busy. Last May we sponsored three busses that took 162 people from across the campus to see the Cubs play. Later in the summer, we awarded seven scholarships to dependents of Civil Service employees and one Carl Johansen scholarship. The scholarships are paid for by a combination of Foundation awards and Council fund raising. Participants greatly enjoyed our fall shopping trip to the Woodfield Shopping Center. The Children's Holiday Party, in conjunction with the A/P Council, was a rousing success. This party features ISU's own Gamma Phi Circus and the entire campus is invited to bring their children and grandchildren. In Spring 2005, we awarded six Civil Service Distinguished Service Awards. This is the highest award a nonacademic employee can receive at Illinois State. We also awarded the Esprit de Corps award to one employee who went above and beyond in support of the Council and the staff.

The Council sponsored its first food drive this year. Five bins of food and personal items were donated to the Compassion Center. Five busses went to Chicago for our second Cubs trip. During the year we held two fund-raisers at a local pizza parlor. Our annual Spring Raffle is an all-out effort with 30-60 prizes donated by local businesses and one large prize (last year it was a digital camera, this year a mini iPod) purchased by the Council. The raffle is always well-received and nets us enough profit to pay for our scholarships.

One issue that the Civil Service Council is particularly proud of this year is the outcome of the Social Security Number/Identity Theft Committee. By June1st the University has stopped using our Social Security Numbers as identifiers. This change was initially precipitated by a memo the Civil Service Council drafted and sent to the Vice President of Finance and Planning, Steve Bragg. By his own words, we inspired him to form the campus-wide committee that has done such a fine job working to correct this problem.

The bottom line is that, through good times and bad, the staff at Illinois State University remains dedicated, hard working people. We staff members are the backbone of this university. The faculty could not teach without our work. What we do here is important. I congratulate each of you for the fine work that you do and for your dedication to this university.

## What The Council Means To Me

I have served on the Civil Service Council for the past 6 years. This has given me the opportunity to wear many hats - from vice-chair to chair to list-server manager to Web designer to sitting on the Academic Senate Committee. I cannot thank the Council and my department enough for allowing me the opportunity to learn more about Illinois State University and to
 grow as an individual with this knowledge. I wanted to be a part of making a difference, and I have learned that change takes time.

The Civil Service Council is not just about parties and raffles. Because of our Council members, Paul Collins and John Moss, who brought it up five years ago, the social security number usage on campus is changing. And that is, to-date, the most important accomplishment that I can remember during my council membership.

As with anything that is done in life, the good must be taken with the bad, and we must grow accordingly. One person can make a difference, and being involved in a group like the Council just makes that one voice louder and backed up by many. The Council's purpose is to get involved and inform the campus, and we do that. I am sure the Council will continue to grow and change even more as time allows. I may never have known the great group of people I have met on campus had I not had this opportunity to serve on the Council. And for that I will be forever grateful.

The pension-related legislation passed by the General Assembly, and expected to be signed by the Governor, is House Amendment 2 to Senate Bill 27. The text of the legislation can be found on the SURS Web site (www.surs.org). This legislation will do the following:

- Create an Advisory Commission on Pension Benefits to prepare a report to the Governor and the General Assembly by November 1, 2005,
- Removes the SURS Board of Trustees' power to set the effective rate of interest credited to member contributions for money purchase formula retirements and gives that power to the state Comptroller. This change is effective beginning July 1, 2005,
- Requires a member's employer to pay to SURS the actuarial value of increased benefits because of earnings increases during the final rate of earnings period in excess of $6 \%$ over the prior year's earnings. This provision does not limit member pensions, but requires the employer to pay directly for any increased benefits resulting. This provision does not apply to earnings increases which are paid pursuant to contracts which are in effect prior to the effective date of this legislation. The effective date is the date that the Governor signs the bill,
- Removes the money purchase formula as a method of calculating retirement benefits for all persons hired on or after July 1, 2005,
- Makes every benefit enhancement enacted in the future expire after five years unless renewed by the legislature and the governor.,
- Makes every benefit enhancement enacted in the future be fully funded,
- Reduces the state contribution to SURS for fiscal year 2006 (July 1, 2005 - June 30, 2006) from approximately $\$ 365$ million to approximately $\$ 167$ million, and
- Reduces the state contribution to SURS for fiscal year 2007 (July 1, 2006 - June 30, 2007) from approximately $\$ 432$ million to approximately $\$ 252$ million.


## New University ID Cards

Over the Memorial Day Weekend, Administrative Information Systems staff completed the University Identification (UID) conversion - taking the Social Security Number (SSN) out of every record and replacing it with a UID. You probably already realize that all UIDs begin with 8 and that you will not use your SSN in any university business as of June 1. But did you know that
 you, too, have some work to do?

According to University policy, SSNs cannot remain on-line anywhere but in the core University table. This means that all of the spreadsheets, databases, e-mail systems, and report files that you have on your computer or your server need to be updated to no longer contain SSNs. Possible fixes include deleting the files, removing the SSNs, changing SSN to UID, or putting the files onto CDs (and storing the CDs in a secure location). Check out
www.ais.ilstu.edu/ssn/Research/Checklist.shtml for more information.
Forms that had collected SSN information may also need to be updated. Simply substitute the SSN fields on the forms with UID since they are both 9 digits in length. Some exceptions are medical forms, insurance forms, and employment/tax forms.

The new University ID system was created to allow the University to help protect the community from identity theft. Even though it may mean some changes in the way you work or perhaps even an additional step in your processes, please do your part. Thank you.

## ISU Night at Wrigley Field Bus Trip



For several years, Bone Student Center has purchased group tickets to a Chicago Cubs game and made these available, at cost, primarily to students. Last year, the Civil Service Council and Bone Student Center collaborated to make additional tickets, along with bus transportation, available to others in the Illinois State community.
