FOREWORD

In this thesis an attempt has been made to investigate the extent to which the Concept of Arab unity has been implemented in inter-Arab states legal relations. With this object in mind the book has been divided into two main parts. The first part presents the concept of Arab unity as it evolved around the middle of the 19th century until the late 1950s. In tracing the development of this concept the present writer has in the main consulted Arab nationalist writers on the subject. In the second part an attempt has been made to examine the more important approaches so far pursued by the Arab states to achieve comprehensive unity. In the last chapter more evidence of the notion of Arab unity was sought in the domestic laws of the Arab states.
